Petition

To the County Commissioners of the County of Lorain and State of Ohio: We the undersigned inhabitants of territory contiguous to and adjoining on the south of the Incorporated Village of Oberlin in said County do petition your honorable body, that the territory hereinofore described be added to, and annexed to the Incorporated Village aforesaid to become a part thereof according to the Statute in such cases made and provided.

Your petitioners further state that said territory prayed to be annexed does contain about fifty inhabitants and that a majority of the legal voters thereof desire said annexation, and further that said territory has been run out and surveyed, and embraces all the territory included in the following outline: viz Beginning at the south East corner of the incorporated Village of Oberlin according to the plat and plan thereof and running south along the tract of the C & R.R. to the south line of Alva Whitney's land, thence West along Whitney's south line and further West to a point where said line touches the C & R.R. and along the south side of said R.R. to a point on a line with the West line of the Incorporated Village of Oberlin, thence North to the south West corner of said Incorporated Village whence East to the place of beginning have petitioned the Commissioners of the County of Lorain praying for annexation of the territory above described to the Incorporated Village of Oberlin aforesaid. And whereas at the September term of said Commissioners the prayer of the said petitioners was granted and no appeal having been made to the Court of Common Pleas, And whereas at the election held in the Incorporated Village of Oberlin aforesaid on the first Monday of April last a majority of the voters of the said Village voted in favor of said annexation. Now therefore be it ordained by the Council of the Incorporated Village of Oberlin, that the annexation of the territory described in said petition and the plat accompanying the same is hereby confirmed and the same is hereby made a part of the Incorporated Village of Oberlin Lorain County Ohio, Passed May 2nd 1861




