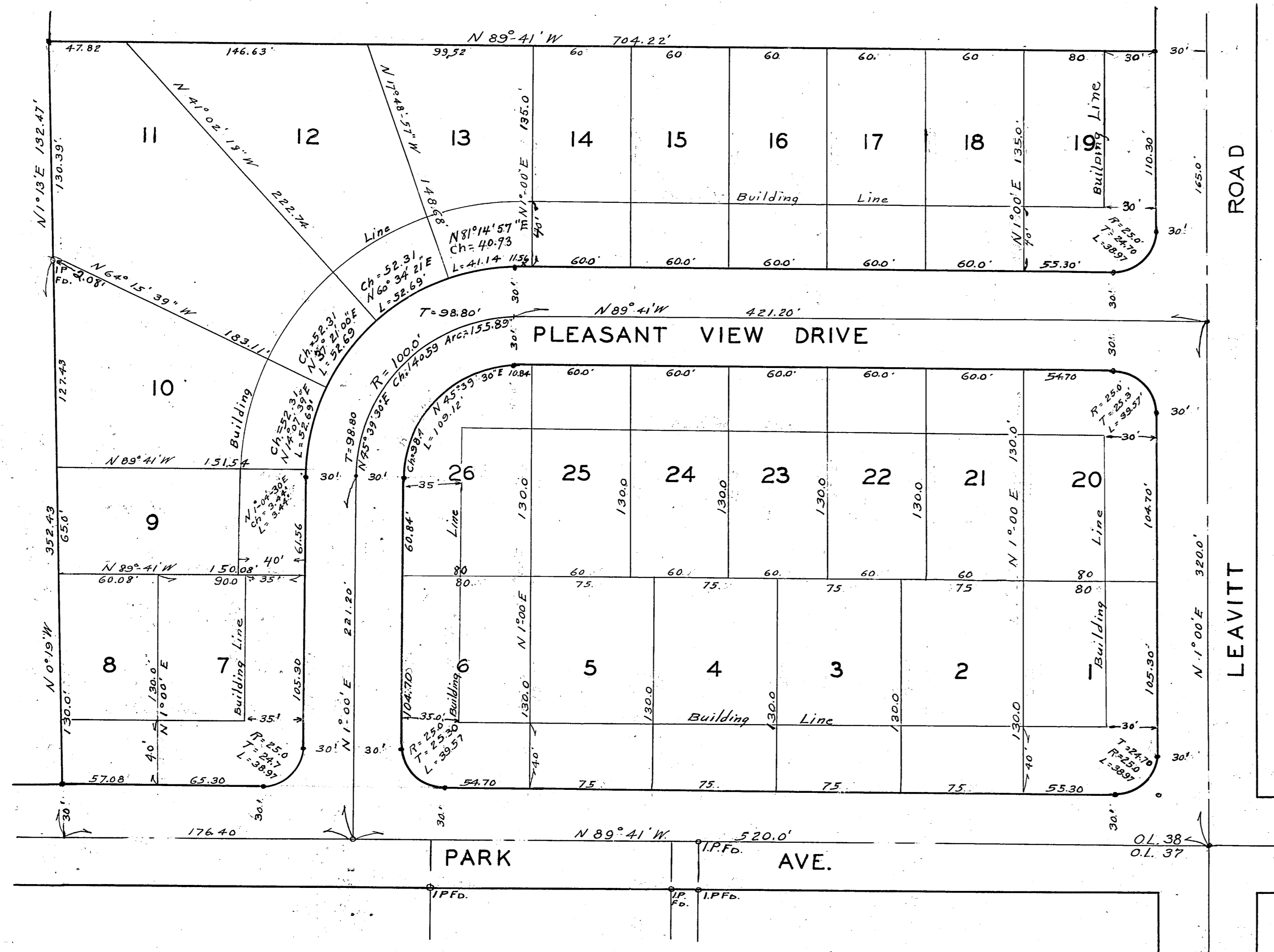
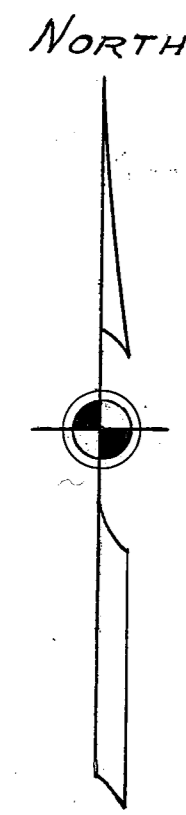


PLEASANT VIEW SUBDIVISION

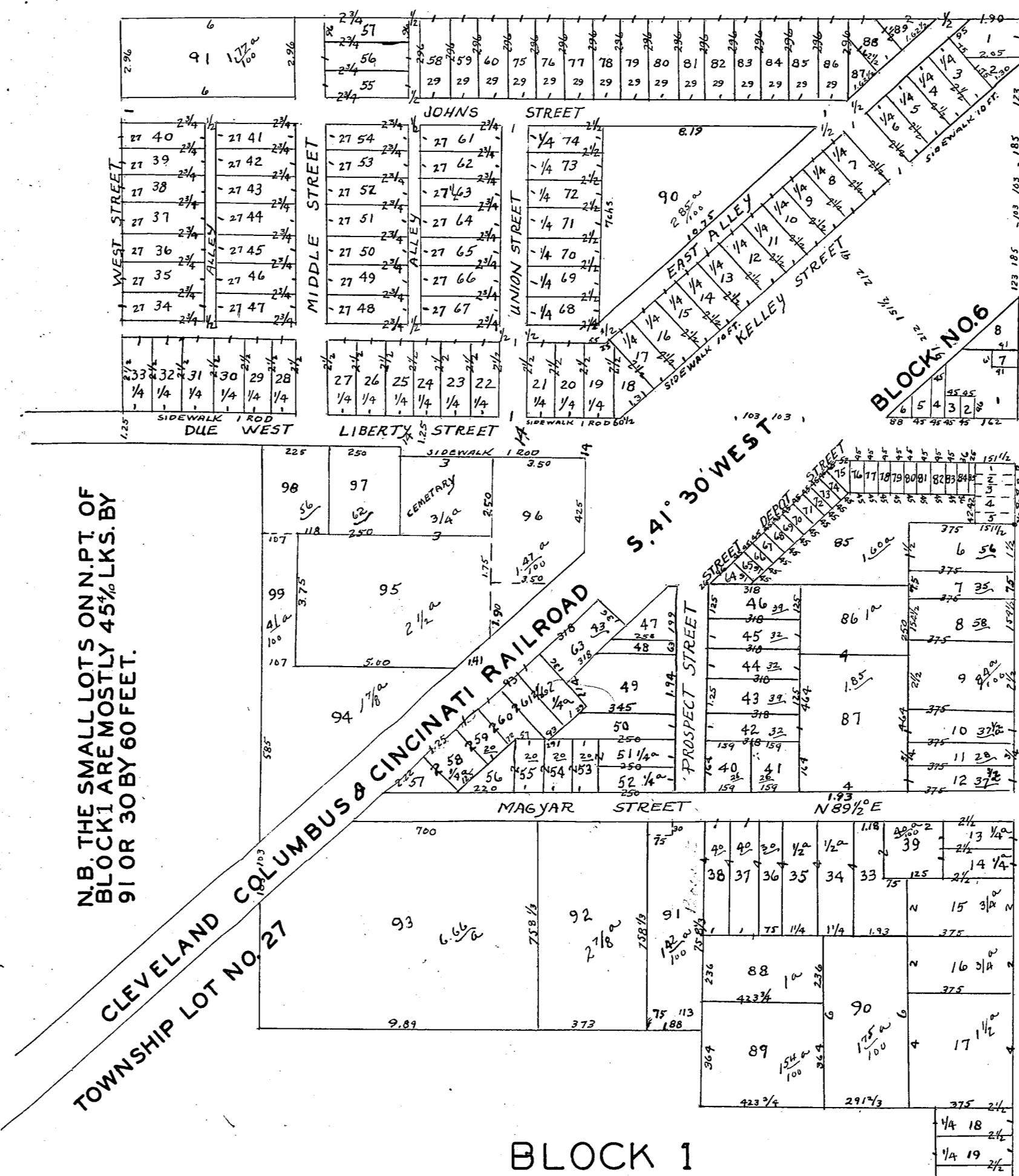

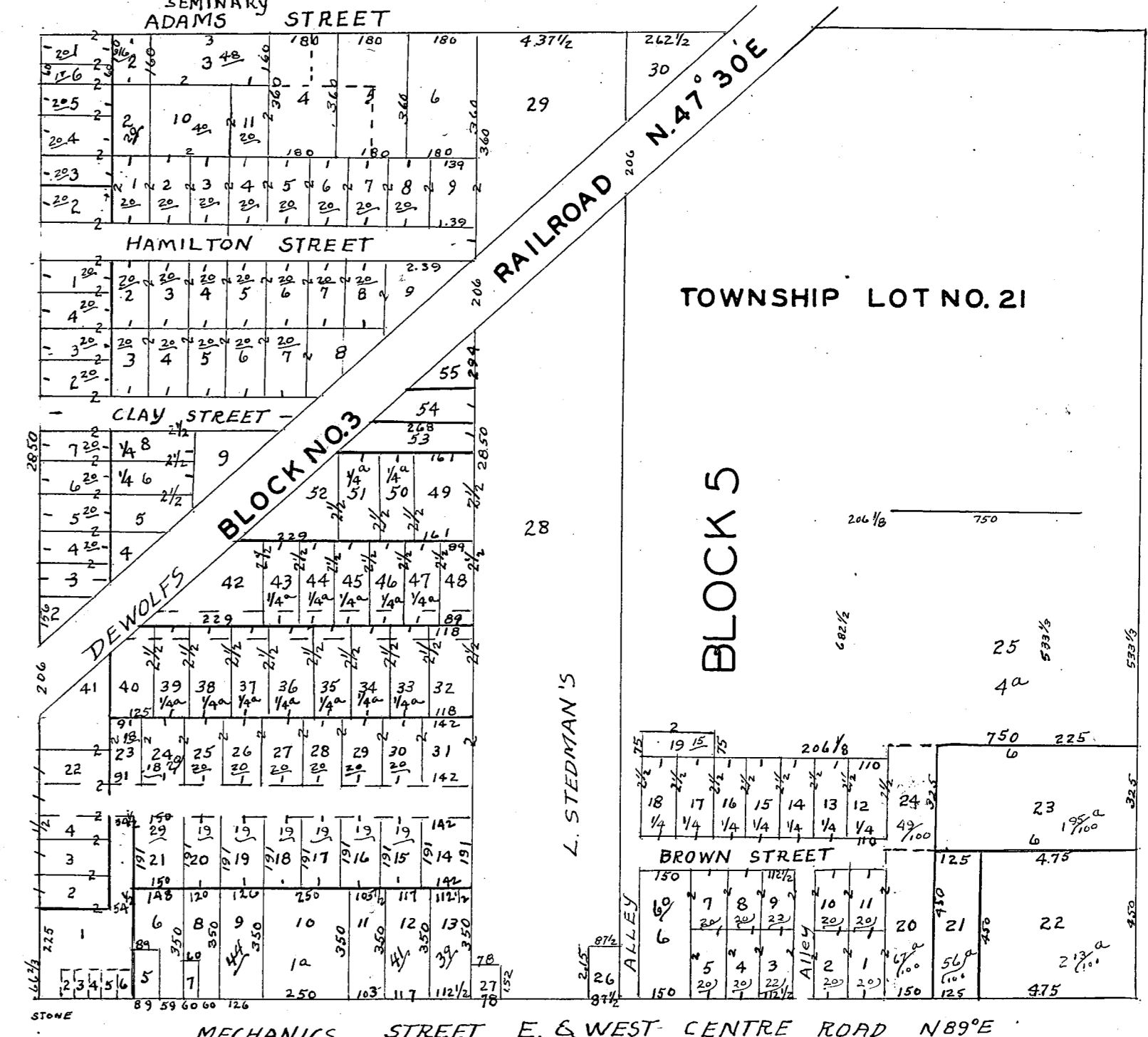
