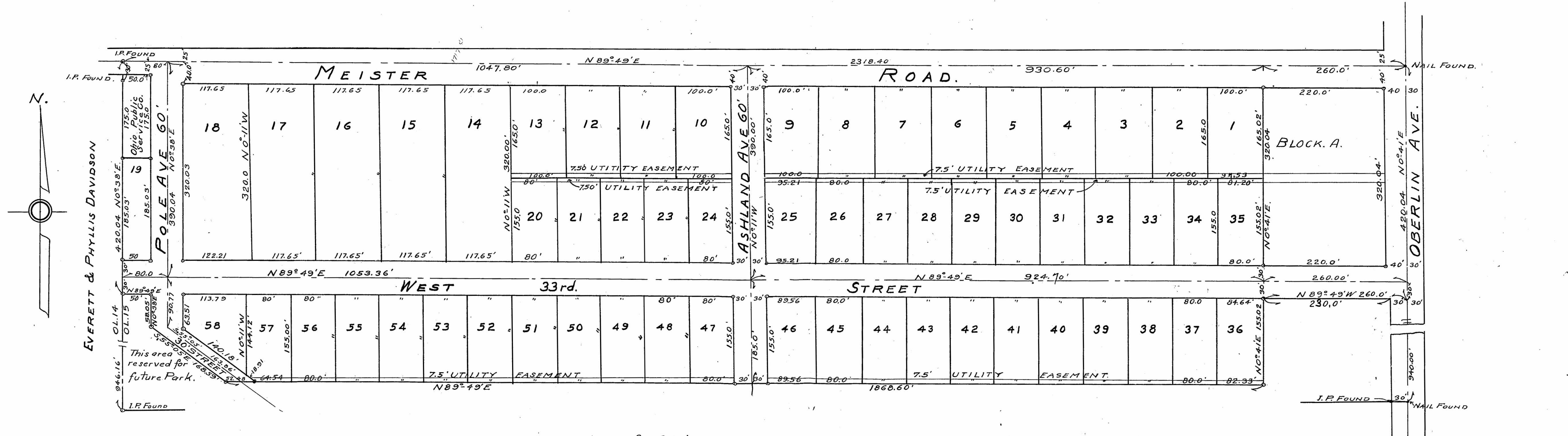


WILLOW CREEK SUBDIVISION NO. 1.
