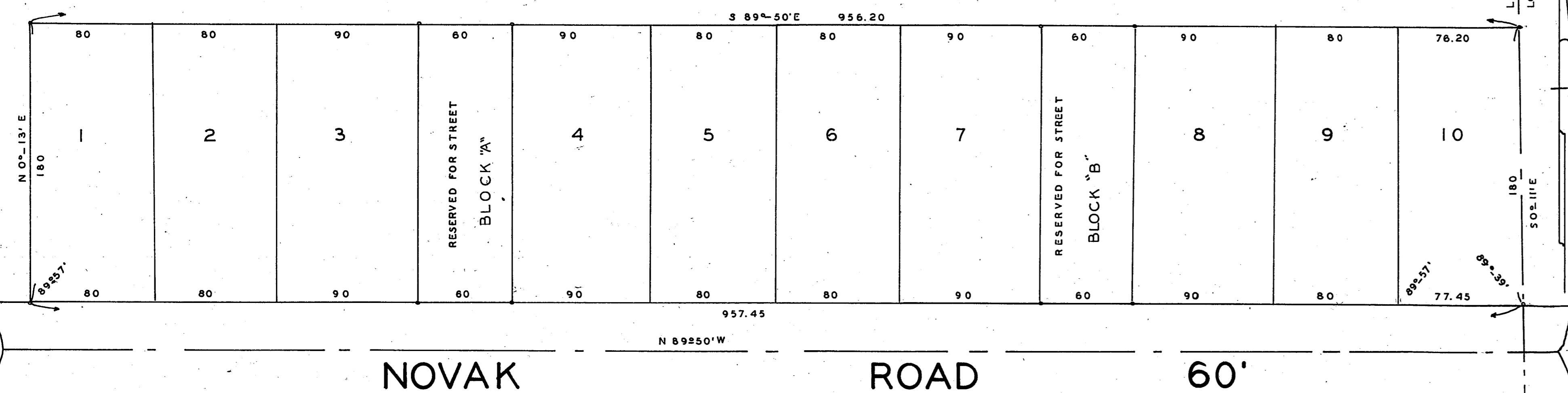


STANN ALLOTMENT NO.1

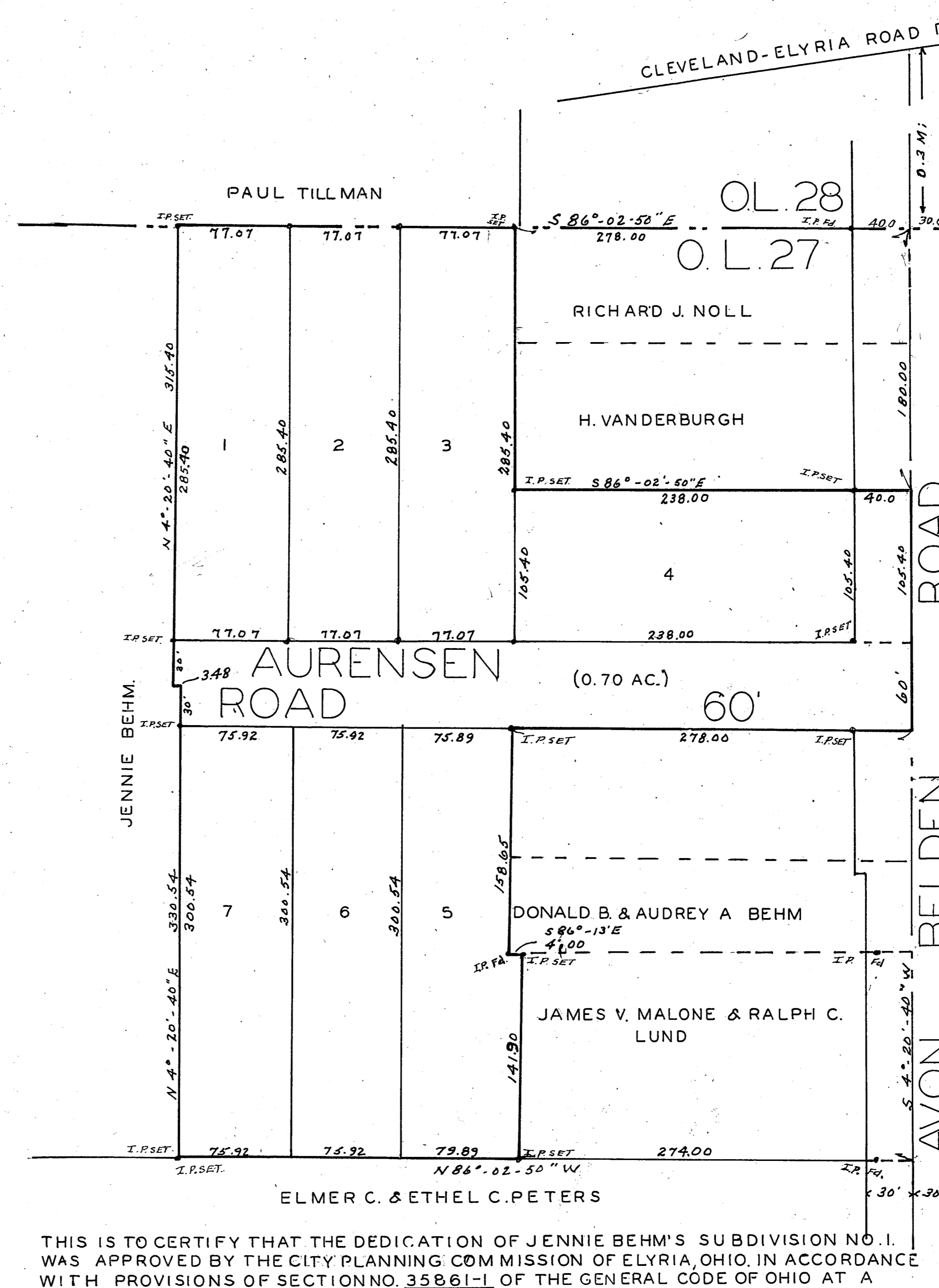
