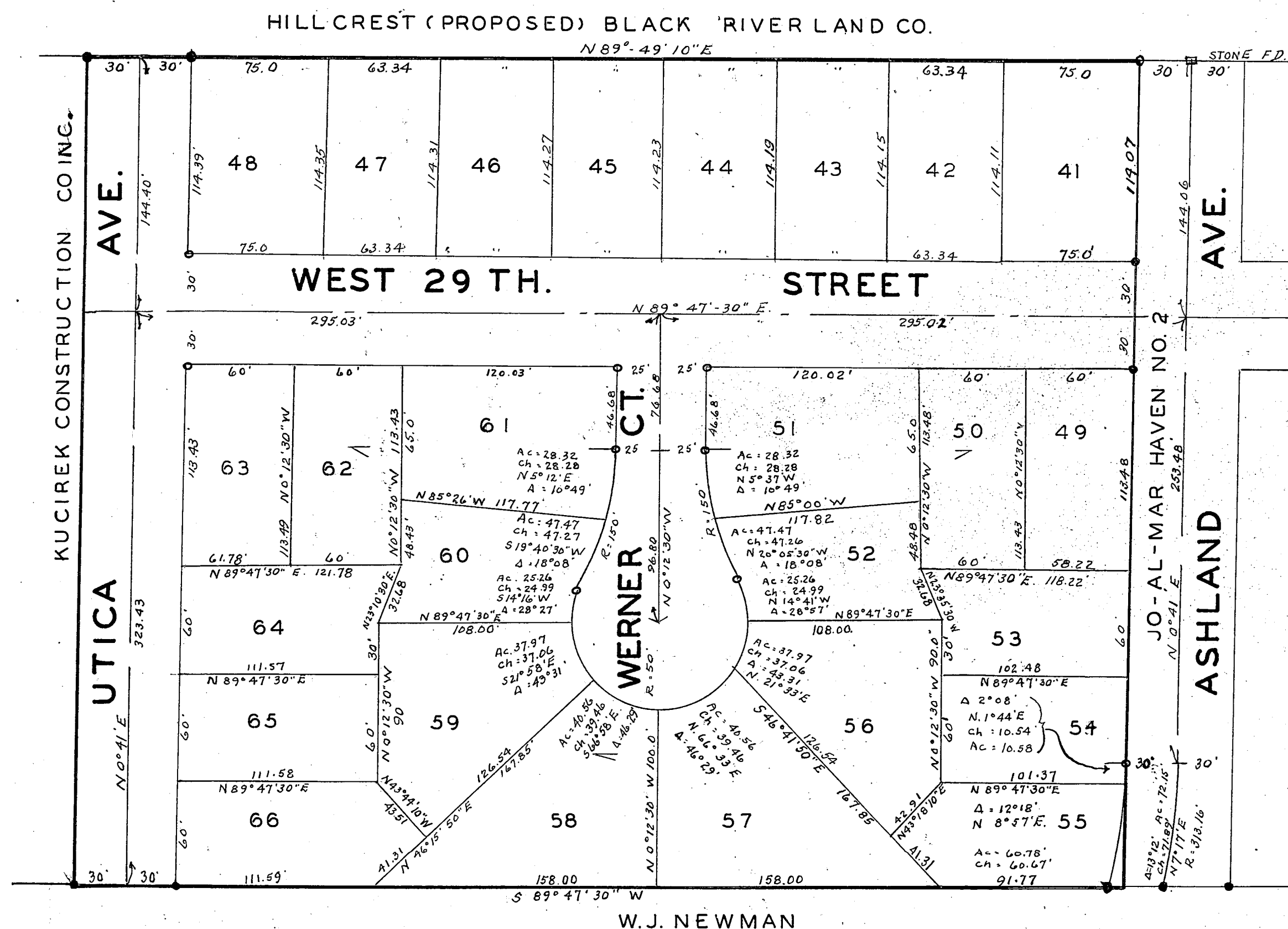


JO-AL-MAR HAVEN SUBDIVISION NO.3.

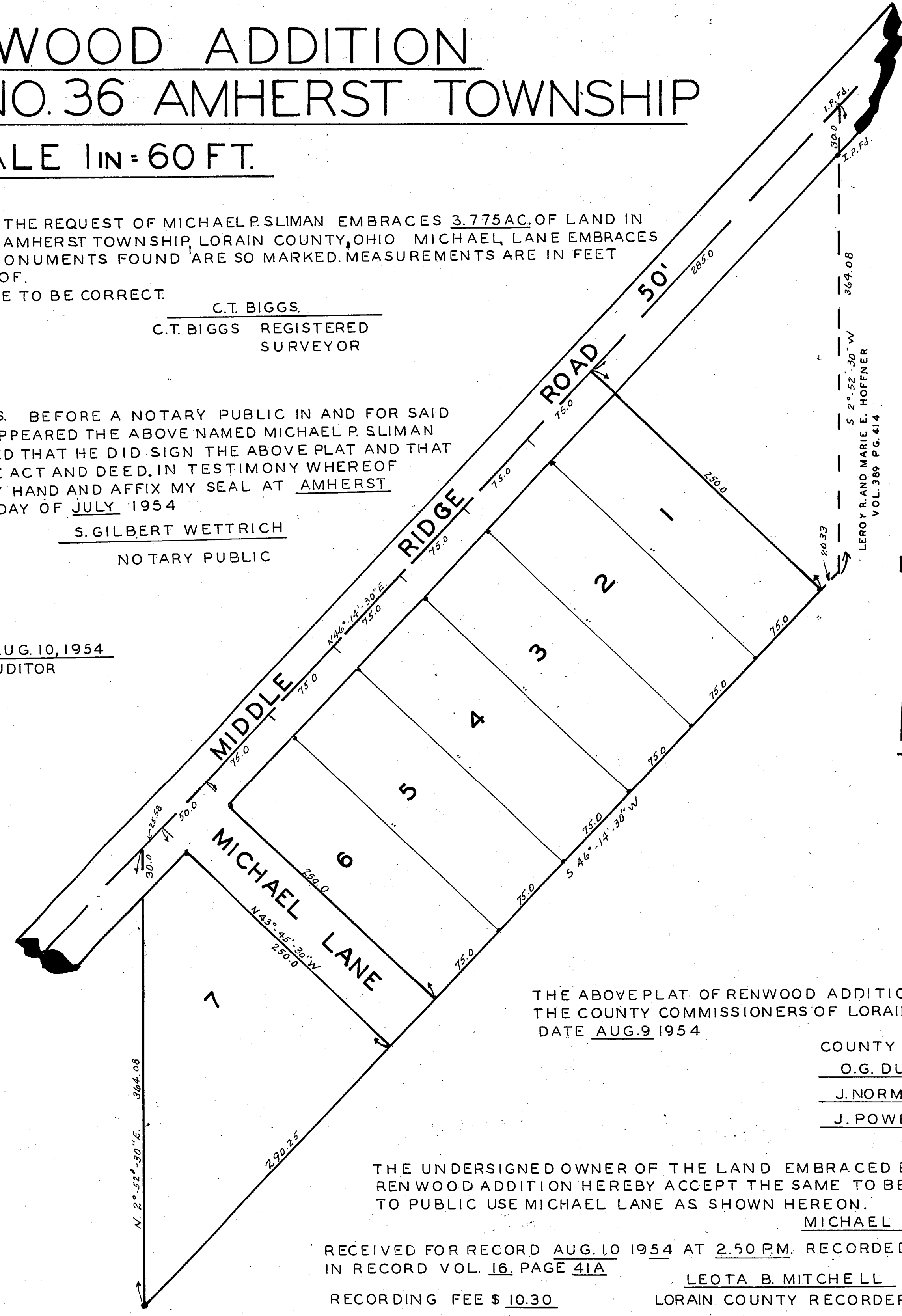
