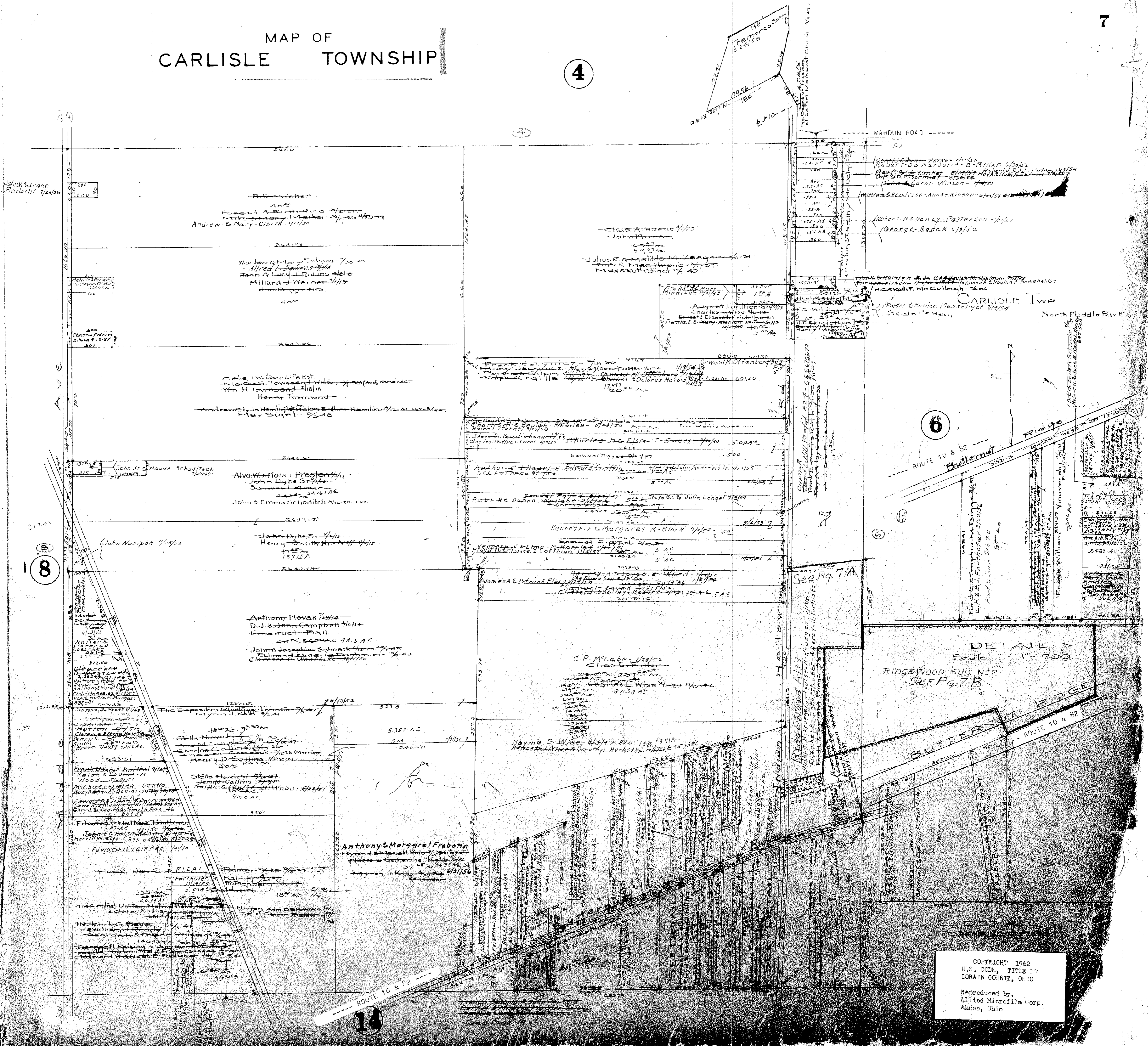


MAP OF
