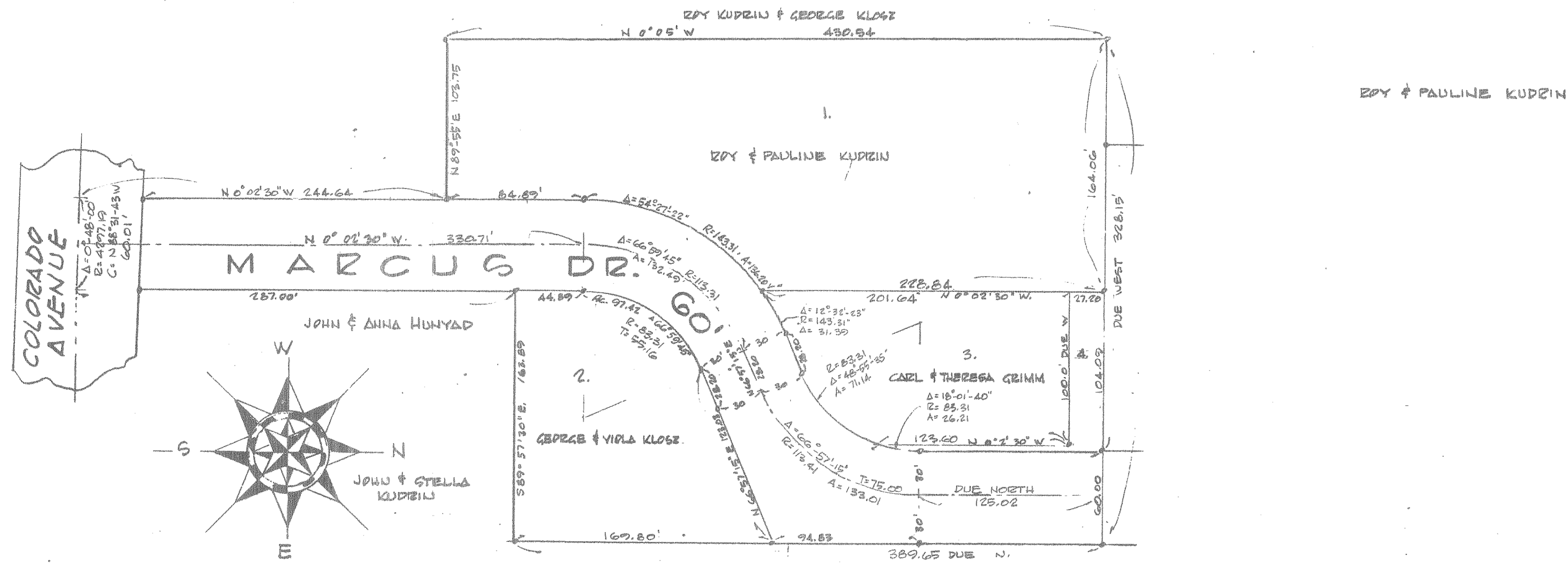


# SHEFFIELD VILLAGE PARK SUBDIVISION
