A DISTANCE OF APPROXIMATELY 740 FEET.

2. THE LAKOCYS AND BESSIE M. TERNES, THEIR HEIRS AND ASSIGNS. DO HEREBY AGREE TO CONSTRUCT AND PAY FOR THE EXTENSION OF ROADWAY, DRAINAGE, WATER LINE AND SANITARY SEWERS SOUTHERLY FROM THE SOUTH PROPERTY LINE OF THE OHIO EDISON PROPERTY TO THE NORTH LINE OF EAST BROAD STREET, IN ACCOR-DANCE WITH THE SPECIFICATIONS PROPOSED BY THE CITY AT THE TIME THE CITY DETERMINES IT NECESSARY TO PROCEED WITH SUCH IMPROVEMENTS OR UPON PETITION BY THE PROPERTY OWNERS, IN ACCORDANCE WITH SECTION TOT OF THE OHIO RE-VISED CODE.
