


GRAPHIC SCALE

LEGAL DESCRIPTION

Situated in the City of North Ridgeville, County of Lorain, and State of Ohio: and known as being part of Original Ridgeville Township Lot 21 bounded and described as follows:

Beginning at the intersection of the centerlines of Center Ridge Road and East Street, thence along the centerline of Center Ridge Road. North 71"21"20" East a distance of 171.57 feet to point in the centerline of Center Ridge Road.

Thence continuing along the centerline of Center Ridge Road, North 70°35'00" East a distance of 48.62 feet to a point in the centerline of Center Ridge Road.

Thence North 24'54'11" West along the centerline of French Creek a distance of 97.53 feet to a point in the centerline of French Creek.

Thence North 40'43'09" West along the centerline of French Creek a distance of 163.92 feet to a point in the centerline of French Creek.


Thence South 89°17'40" West passing through an iron pin found on the east right of way line of East Street a distance of 63.91 feet to a point in the centerline of East Street.

Thence South 00'42'20" East along the centerline of East Street a distance of 282.95 feet to the centerline of Center Ridge Road and the place of beginning.

Containing within said bounds 0.888 acres of land more or less and subject to all legal highways.


