

COUNTY OF LORAIN AND STATE OF OHIO OF WHICH 0.2132 ACRES LIE IN PRIVATE STREET DEDICATION, 2.4780 ACRES LIE IN COMMON AREA AND 0.6354 ACRES LIE IN LOTS NUMBERED 17 TO 26, INCLUSIVE.
