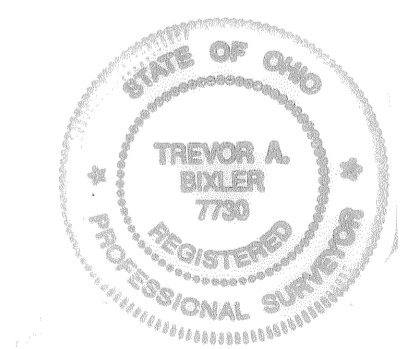
AREA MAP
