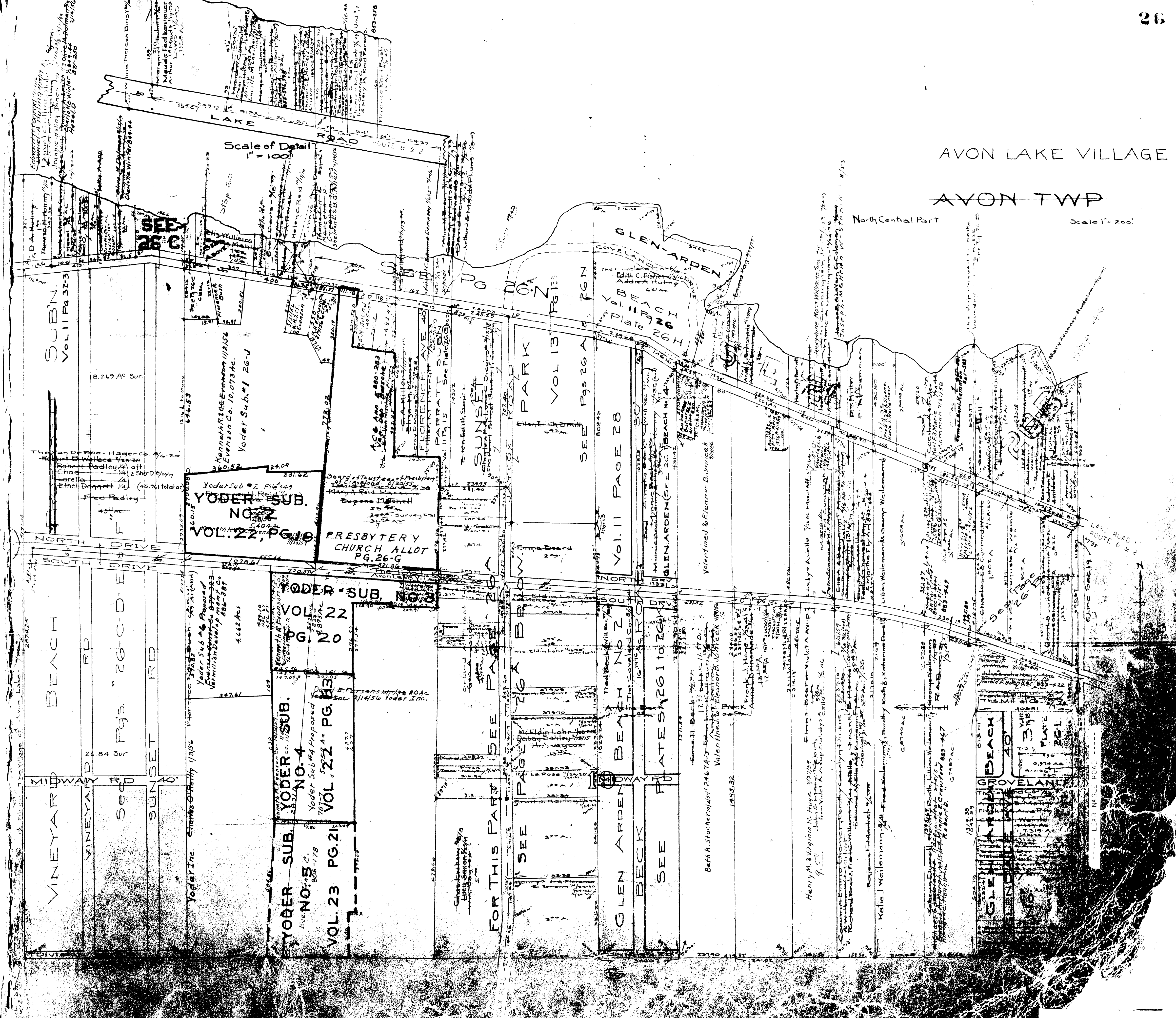


NELSON WALKER SUBDIVISION
