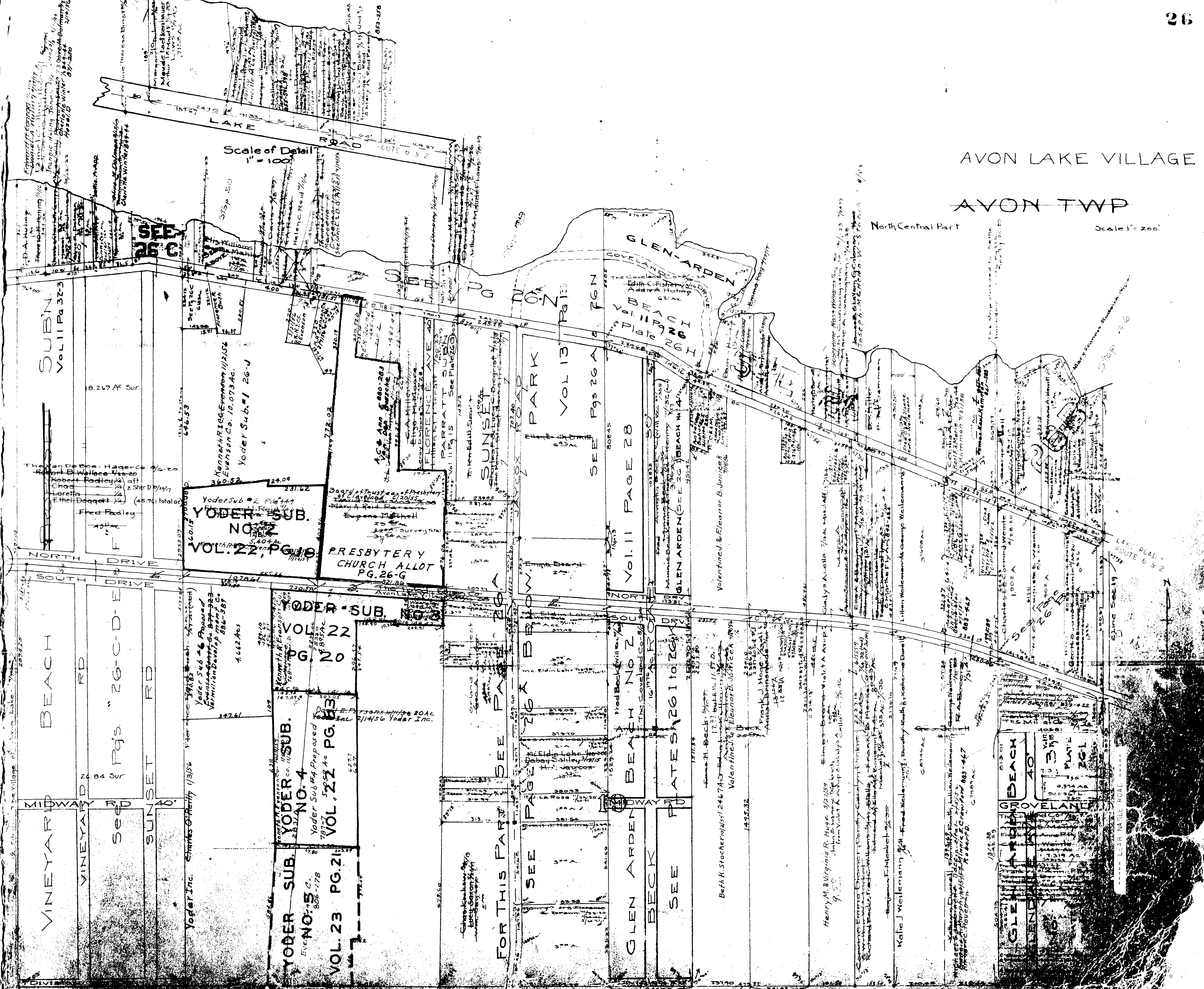

North Central Part Scale 1" = 200'

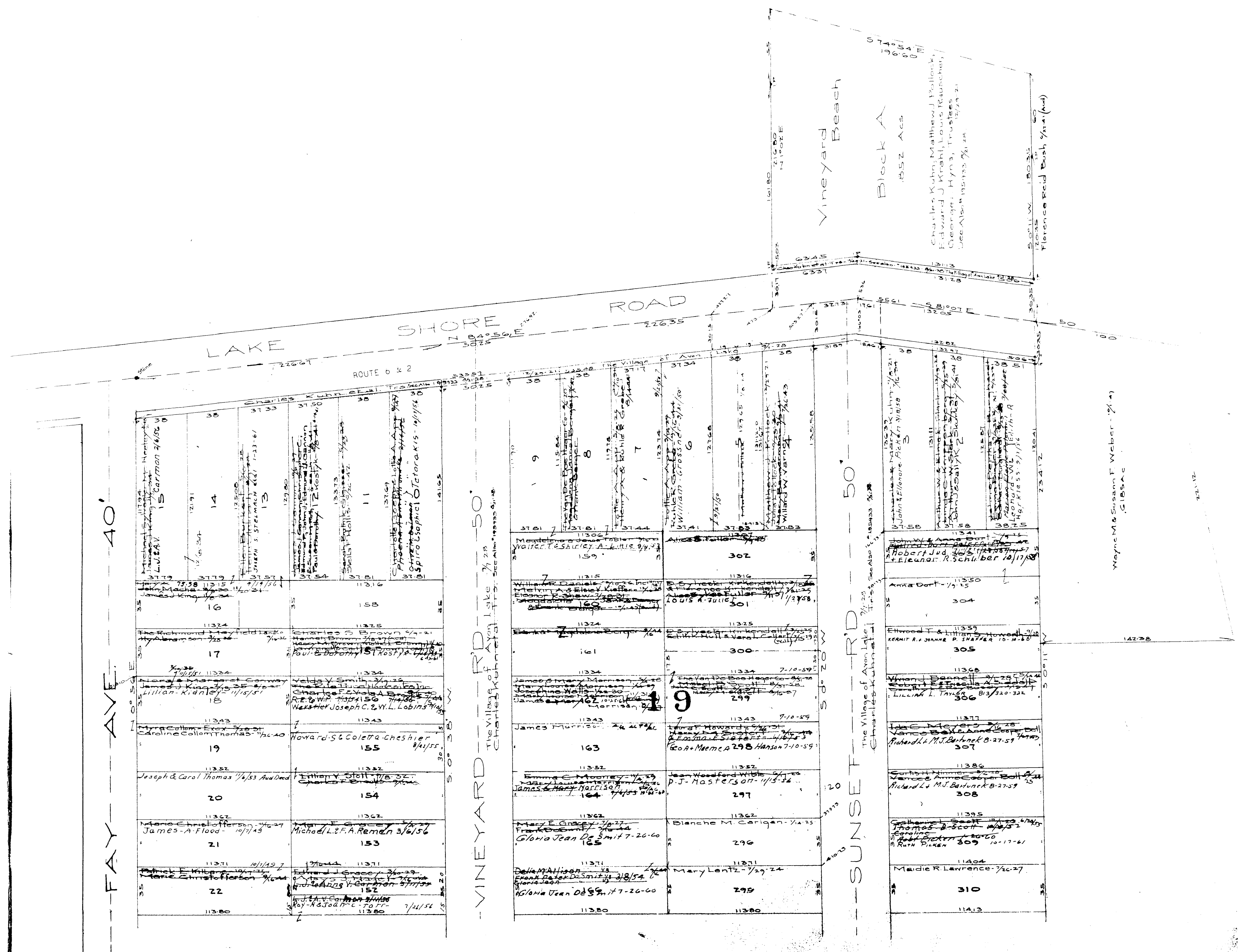
