This was the day for the public hearing duly advertised for the proposed vacation of Maplewood Drive, Original Lot 12, of the Brace Tract in Elyria Township, Lorain County, Ohio.

Discussion was held and the following resolution was adopted:

WHEREAS, after due and logal advertising and personal notice this is the day fixed for the public hearing on the vacation of Maplewood Drive, Original Lot 12, Brace Tract, Vol. 10, Page 34 and Interurban Allotment Plat Vol. 5, Page 29 in Elyria Township, Lorain County, Ohio;

WHEREAS, notices were forwarded to the Utility Companies. Columbia Gas and CenturyTel and Alltel Telephone only responded stating they have no facilities or casement within this area; and

WHEREAS, notice of this public hearing was published in the Chronicle Telegram on June 26 and July 3, 2000 and notices were also forwarded to property owners and the Clerk of Elyria Township; and

WHEREAS, Assistant County Prosecutor Jerry Innes, administered an oath to those wishing to make a comment on this vacation; and

WHEREAS, Commissioner Vasi asked for anyone in favor of this vacation to state their comments.

Mr. Alessio, Rowland Enterprises gave a brief statement on the project and requested Commissioners approval. Mr. Alessio obtained the required signatures and filed the Petition requesting this vacation; and

WHEREAS, Commissioner Vasi asked for anyone in opposition to this vacation to state their comments. No one was present; and

WHEREAS, County Engineer reviewed said Petition by letter dated April 18, 2000 indicating that the description correctly follows the map and petition for the portion that can be vacated by the County. The plat shows the part of Maplewood Drive in the City of Elyria as cross-hatched. The portion in the City would have to be vacated by the City of Elyria, Ohio. The Engineer recommended the County Prosecutor's Office review and advises on whether the lots that abut the requested vacated Maplewood Drive would become landlocked, and the division of the vacated street since 30 feet originally came from the plat to the sough and 20 feet originally came form the plat to the north. The Engineer indicated that easements for existing utilizes should be maintained; and

WHEREAS, County Prosecutor by letter dated May 8, 2000 indicated that in answer to the question of the are being "landlocked", this are would be landlocked, but his land being divided is that half of the 50' width which would go to the abutting landowners north of the road; half would go to the abutting landowners south of the road; and

NOW, THEREFORE BE IT RESOLVED, that Commissioner Blair moved to grant the proposed vacation of Maplewood Drive, Original Lot 12, of the Brace Tract in Elyria Township, Lorain County, Ohio and said approval is determined to be for the benefit of the public convenience and welfare. Mr. Innes requested an Executive Session on updates to pending litigation issues.

President's report

Commissioner Vasi congratulated the LEPC on receiving an award of recognition from the State on August 10 at the conference.

Commissioner Vasi said it is her intention to establish a mental health task force with the goal of developing a system of quality care for mentally ill defendants. This group will include leaders in law enforcement, criminal justice and mental health as well as citizens that have survived and/or have been diagnosed with mental illness. Specifically, the group will examine diversion from arrest and incarceration; services for defendants in custody and in the community.

The dual objectives of identifying and for treating the mentally ill in the criminal justice system who are in need of assistance, not punishments, will be achieved.

Commissioner Ross suggested that a meeting be set up with Amy Levin, Lorain County Board of Mental Health.

Commissioner Vasi said meetings have been held with Board of Mental Health, Nord Center, Farwest, etc. and everyone is aware that things need to be done. Senator Strickland, DeWine, Kennedy, etc. have introduced three bills for mental illness. Also 8 out of 10 incarcerations in Lorain County are mentally ill and throughout the state is 16%. Mental illness is not people that are crazy it is a disease just like heart or cancer but the public mark people to have them committed and this illness can be brought on from birth like a chemical imbalance in the brain.

Commissioner Vasi said she would like to see the task force focus on a way to find a unique need for non-violent mentally ill offenders, specified training for law enforcement, corrections and judicial personnel. Diversion them to outpatient and inpatient mental health treatment and centralize case management and regulation in guidelines, research grants and treatment approaches and involvement of family members.

Commissioner Vasi asked for any comments or concerns and anyone that would be interested on serving on this committee.

Minnic Wade-Reed-Young suggest an inter disciplinary team be added to the task force of parents who have the mentally ill problems before them and have deaft with them.
