WHEREAS, an Expedited 1 petition and map for annexation of 1.77 acres from Pittsfield Township to the City of Oberlin were filed with the Clerk of Board of Commissioners of Lorain County, Ohio on December 6, 2005 by Cary J. Zabell, Esq., of Cary J. Zabell Co., LPA, is Acting Agent for Doran G. and Joann J. Portman; and

WHEREAS, the petition, map and description was forwarded to the Engineer and Auditor for their reviews; and

WHEREAS, December 12, 2005 Lorain County Engineer submitted a letter after review of the description and map of the proposed Annexation of 1.77 acres of which Parcel #1 has 1.51 acres and Parcel #2 has 0.26 acres, in Original Lot #16 of the Pittsfield Township to the City of Oberlin, Ohio.

Cary J. Zabell, Esq., of Cary J. Zabell Co., LPA, is Acting Agent for Doran G. and Joann J. Portman, only owners of the parcels.

Upon reviewing the map and description we have found that the legal description does follow the perimeter of the map and both appear to be accurate. The parcel to be annexed is contiguous with the City of Oberlin.

WHEREAS, said petition was filed as an Expedited Type 1 Annexation as authorized under R.C. 709.022 and the Board of Commissioners met on December 15, 2005, the next regular session following filing of the petition;

WHEREAS, Assistant County Prosecutor Innes said this Expedited Type 1 annexation does not require a hearing. The petition has been signed by all owners, a map and legal description were received along with the agent and an annexation agreement; and

WHEREAS, Commissioner Blair asked if there were any comments to be paid for or against; and there being none; and

WHEREAS, the petition read as follows:

Petition for annexation – pursuant to Ohio Rev. Code Ann. 709.022 To The Board of County Commissioners, Lorain County, Ohio:

Doren C. Portman and Joann J. Portman (collectively, the "Portmans") are the sole owners of the real property located at 14911 State Route 58, Oberlin, Ohio, further known as parcels numbered 1400016000018 and 14000160000031 (the "Subject Property"). WXZ Acquisition Co., LLC ("WXZ") has entered into a Purchase of Sale Agreement with the Portmans to acquire the Subject Property for development, subject to this Petition for Annexation on an Expedited 1 basis. The Subject Property contains 1.77 acres of land.

The Portmans and WXZ hereby petition for honorable body to annex the Subject Property to the City of Oberlin, Lorain County, Ohio.

This Petition for Annexation is being made pursuant to that certain Agreement between the City of Oberlin and the Board of Township Trustees of Pittsfield Township, Lorain County, Ohio dated August 2, 1991 in which the Township has agreed not to object to the annexation of property to the City of Oberlin if such property is located within the geographical area defined therein. A copy of the Agreement is attached hereto as Exhibit A.

Attached as $\underline{\text{Exhibit B}}$ is an accurate legal description of the perimeter of the Subject Property, which falls within the geographical area defined in the Agreement between the City of Oberlin and the Board of Township Trustees of Pittsfield Township, Lorain County, Ohio. Attached as $\underline{\text{Exhibit C}}$ is an ALTA/ASCM Survey of the Subject Property. Attached as $\underline{\text{Exhibit E}}$ is a list of the properties adjacent to the Subject Property.

The Subject Property is contiguous to the City of Oberlin. WXZ intends to develop the Subject Property, providing economic improvement and job opportunities to the area.

Situated in the Township of Pittsfield, County of Lorain, State of Ohio, being part of Original Township Lot Number 16, bounded and described as follows:

Beginning at a point in the centerline of Ashland Oberlin Road (State Route 58) as established by the Ohio Department of Highways as shown on the Centerline Survey Plat for Lorain 58 (7.98) as recorded in Plat Book Volume 25, Page 47 of the Lorain County Records of Deeds; said point also being a monument box and also being on the North line of Original Lot 25 and the South line of Original Lot 16;

Thence North 0°58'23" east along said centerline a distance of 376.67 feet to a point;

Thence North 86°0'23" east a distance of 50.20 feet to an iron pin; Said point being on the easterly right of way line of the Ashland-Oberlin Road presently established;

Said point also being the principal point of beginning of lands herein described:

Thence North 0°58'23" east along the easterly right of way line of the Ashland-Oberlin Road a distance of 249.73 feet to an iron pin;

Thence South 89°01'37" east a distance of 282.09 feet to an iron pin;
Thence South 3°36'23" west a distance of 227.04 feet to an iron pin;
Said point also being on the north line of land conveyed to the Macdermott

Said point also being a monument box and also being on the North lien of Original Lot 25 and the South line of Original Lot 16;

Thence North 0°58'23" east along the said centerline of State Route 58 (7.98) a distance of 630.62 feet to a point;

Thence South 89°01'37" east a distance of 50.00 feet to an iron pin; Said point also being on the easterly right of way line of a Perpetual Highway Easement conveyed to the Sate of Ohio by easement recorded in Volume 983, Page 781 of the Lorain County Records of Deeds;

Said point also being the principal place of beginning of lands herein described;

Thence North 0°58'23" east along the easterly line of right of way of aforesaid Perpetual Easement along the State Route 58 (7.98) a distance of 40.00 feet to an iron pin;

Thence South 89°01'37" east a distance of 283.89 feet to an iron pin; Thence South 3°36'23" west a distance of 40.04 feet to an iron pin;

Thence North 80°01'37" west along the north line of lands conveyed to Jo Ann and Doren Portman by Deed dated September 4, 1974, recorded in Volume 1110, Page 319 of the Lorain County Record of Deeds a distance of 282.09 feet to an iron pin in the Northwest corner of lands conveyed to the aforesaid JO Ann and Doren Portman which is the principal; point of beginning; be the same more or less, but subject to all legal highways.

Commencing at a point in the centerline of Ashland Oberlin Road (State Route 58 – variable width) as established by the Ohio Department of Highways as shown on the Centerline of Survey Plat for Lorain 58 (7.98) as recorded in Plat Book Volume 25, Page 47 of the Lorain County Records of Deeds; said point also being a monument box and also being on the north line of said Original Lot 25 and the South line of Original Lot 16;

The Petition contains the signatures of all the property owners in the territory to be annexed.

- 1. The Petition contains an accurate legal description of the perimeter of the territory proposed to be annexed.
- The Petition contains an accurate map or plat of the territory proposed to be annexed.
- 3. The Petition contains the name of the person acting as statutory agent for the petitioners.
- 4. Filed with the Petition is a list of all the tracts, lots or parcels in the territory proposed to be annexed together with all the tracts, lots or parcels located adjacent to the territory to be annexed or directly across the road, including the name and mailing address of each owner and the permanent parcel number of each parcel.
- 5. Filed with the Petition is an Annexation Agreement between the City of Oberlin and the Board of Trustees of Pittsfield Township.

BE IT FURTHER RESOLVED that:

- I. Upon the findings that all of the conditions of annexation as contained in Revised Code Section 709.022 have been met, the Petition as presented is granted, incorporating the Annexation Agreement between the City of Oberlin and the Board of Trustees of Pittsfield Township.
- II. Herein the annex area will not be excluded from the Township
- III. The Clerk is directed to enter the resolution upon the journal of the Board and send a certified copy of the record (including all resolutions, the petition, the map and all other papers on file to the Clerk of the City of Oberlin.
