road right of way being all of Quarry Road
(unimproved), Columbia Township, Lorain County
Ohio

November 17, 2005

WHEREAS, after due and legal advertising and personal notice this is the day fixed for the public hearing on the Vacation of an existing road right of way being all of Quarry Road (unimproved) Columbia Township, Lorain County, Ohio; and

WHEREAS, Resolution No. 05-819 on October 6, 2005 received and journalized said petition and scheduled the view on November 2, 2005 at 10:00 am. and the public hearing on November 17, 2005 at 10:00 a.m.; and

WHEREAS, petition was forwarded to the County Engineer for review, and by letter dated September 21, 2005 the Engineer stated ""the legal description and map concurs with the current tax map and county records, however, an older tax map shows Quarry Road extended further west from Columbia East River Road. He recommends that the vacation be as described in the petition and any extensions thereof to the Rocky River. Parcels abutting the proposed Quarry Road vacation are all owned by the Hat Creek Company, Inc."; and

WHEREAS, Notices were also forwarded on July 25, 2005 as follows: Alltel Ohio, Inc., Century Telephone, Columbia Gas of Ohio, Lorain County Rural Water Authority, Lorain Medina Rural Electric Co-op, Inc., Ohio Edison Company, Ohio Department of Natural Resources, Lorain County Planning Commission and the following responses were received; and

Alltel Communications responded on August 15, stating they have no telecommunications facilities within the area to be vacated.

Lorain County Planning Commission responded on August 20, recommending the vacation. This property is all owned now by one owner and it has never been improved or used by or for the public.

Columbia Township Trustees responded on September 8, 2005 stating they have no objections to this vacation.

And:

WHEREAS, notice of this public hearing was published in the Chronicle Telegram on October 13 and 20, 2005 and notices were also forwarded to 9 property owners and the Clerk of Columbia Township; and

WHEREAS, Assistant County Prosecutor Jerry Innes, administered an oath to those wishing to make a comment on this vacation; and

WHEREAS, Commissioner Blair asked if there were any comments from the Engineer's Office.

Mr. William Holtzman said this property is located off East River Road by what use to be Wildwood Park an unimproved paper street, which is owned by Hat Creek company; and

WHEREAS, Commissioner Blair asked if there were any comments from the Township Trustees.

Mr. Ken Roth, Columbia Township Trustee said the Trustees have no objections; and

WHEREAS, Commissioner Blair asked for anyone in opposition to this vacation to state their comments. No one responded; and

WHEREAS, Commissioner Blair asked for anyone in favor to this vacation to state their comments;

Mr. Twining, Director, Lorain County Community Development Department confirmed that the Lorain County Planning Commission has no objections and recommends this vacation.

Commissioner Blair stated Mr. Holtzman and herself went on the view and just wondered if anyone knew why this vacation was being asked for, even though it is not required. There was no response.

NOW, THEREFORE BE IT RESOLVED, that Commissioner Blair moved to grant the proposed vacation of Vacation of an existing road right of way being all of Quarry Road (unimproved), Original Lot #39, Columbia Township, Lorain County, Ohio and said approval is determined to be for the benefit of the public convenience and welfare. Commissioner Kokoski seconded the motion.

WHEREAS, said Petitions read as follows:

We, the undersigned residents of the Township of Columbia, County of Lorain, State of Ohio, do hereby petition to vacate an existing road right-of-way, said right-of-way being all of Quarry Road (unimproved) as recorded. This street is described as follows:

Situated in the Township of Columbia, County of Lorain and State of Ohio and known as being part of Original Columbia Township Lot No. 39 and is bounded and described as follows:

Beginning at a point on the centerline of East River Road, S.R. 252, 60 feet in width at the southeasterly corner of a parcel of land conveyed to Daniel J. Vedda and Rhonda L. Vedda by deed recorded on May 30, 2002 and is recorded in Instrument No. 832710#1839 of Lorain County Recorders Records, said point being South 11°34'30" West, 1,493.64 feet from the intersection of the centerline of East River Road and the northerly line of Lot No. 22;

Thence South 11°34'30" West, along the centerline of East River Road, 223.77 feet to a point thereon at the PRINCIPAL PLACE OF BEGINNING of the premises herein to be described;

Thence South 11°34'30" West, continuing along the centerline of East River Road, 22.01 feet to a point thereon;

Thence North 79°47'30" West, along the southerly right of way line of Quarry Road, 250.00 feet to a point;

Thence North 11°34'30" East, along the westerly end of Quarry Road, 22.01 feet to point;

Thence South 79°47'30" East, along the northerly right of way line of Quarry Road 250.00 feet to the Principal Place of Beginning and containing 0.1263 acres of land according to a survey by Guy P. Haney, Professional Surveyor No. S-7631 for Fechko Excavating dated April 2005.

Bearings are based on an assumed meridian and are used herein to indicate angles only.

BE IT FURTHER RESOLVED, that the land is within the limits of said street as they are now established, shall forever remain, notwithstanding the passage of this resolution, subject to the rights of utilities now maintaining structures, fixtures and appurtenances in, under, over or upon said lands, to continue to maintain such structures, fixtures and appurtenances, and to enter upon said lands wherever reasonably necessary to do so for the purpose of inspecting, altering, replacing, repairing, patrolling and maintaining such structures, fixtures and appurtenances.

FURTHER BE IT RESOLVED, that a copy of this resolution be forwarded to the County Recorder, Auditor, Engineer, Tax Map and Columbia Township Trustees for recording and filing.
