ORDINANCE NO. 06-19 AC CMS

**AN ORDINANCE ACCEPTING THE ANNEXATION OF APPROXIMATELY 1.77 ACRES
OF REAL ESTATE TO THE CITY OF OBERLIN UPON APPLICATION
OF THE OWNERS, DOREN C. PORTMAN AND JOANN J. PORTMAN, 14911 STATE
ROUTE 58**

WHEREAS, a petition for the annexation of certain territory containing approximately 1.77 acres of land within Pittsfield Township was duly filed by the property owners, Doran C. Portman and Joann J. Portman; and

WHEREAS, the petition was duly considered by the Board of Commissioners of Lorain County, Ohio, on December 15, 2005; and

WHEREAS, the Board of County Commissioners has approved the annexation of the territory to the City of Oberlin, as hereinafter described; and

WHEREAS, the Board of County Commissioners certified the transcript of the proceedings in connection with the annexation with the map and petition required in connection therewith to the Clerk of Council who received same on December 21, 2005; and

WHEREAS, sixty (60) days from the date of that filing have now elapsed in accordance with the provisions of Section 709.04 of the Ohio Revised Code.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the application of the property owners, Doren C. Portman and Joann J. Portman, for the annexation of the following described territory in the County of Lorain and adjacent to the City of Oberlin:

See Exhibit A attached.

an accurate map of which territory, together with the petition for its annexation and other papers relating thereto, and a certified transcript of the proceedings of the Board of County Commissioners of Lorain County in relation thereto are on file with the Clerk of Council of the City of Oberlin, be and the same is hereby accepted.

SECTION 2. That said territory so annexed is hereby zoned "R1-A", pursuant to Section 1329.03 of the Codified Ordinances of the City of Oberlin, and is hereby subject to all conditions stipulated under such district and all other regulation and restrictions of the City of Oberlin now or hereinafter promulgated.

SECTION 3. That the Clerk of Council is hereby authorized and directed to make three (3) copies of this ordinance to each of which shall be attached a copy of the map accompanying the petition for annexation, a copy of the transcript of proceedings of the Board of County Commissioners relating thereto and a certificate as to the correctness thereof. The Clerk of Council shall then forthwith deliver one copy to Mark R. Stewart, Lorain County Auditor, one copy to Judy Nedwick, Lorain County Recorder, and one copy to Kenneth Blackwell, Secretary of State, and shall file notice of this annexation with the Lorain County Board of Elections within thirty (30) days after it becomes effective, and shall do all other things required by law therein.



It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance shall take effect at the earliest date allowed by law.

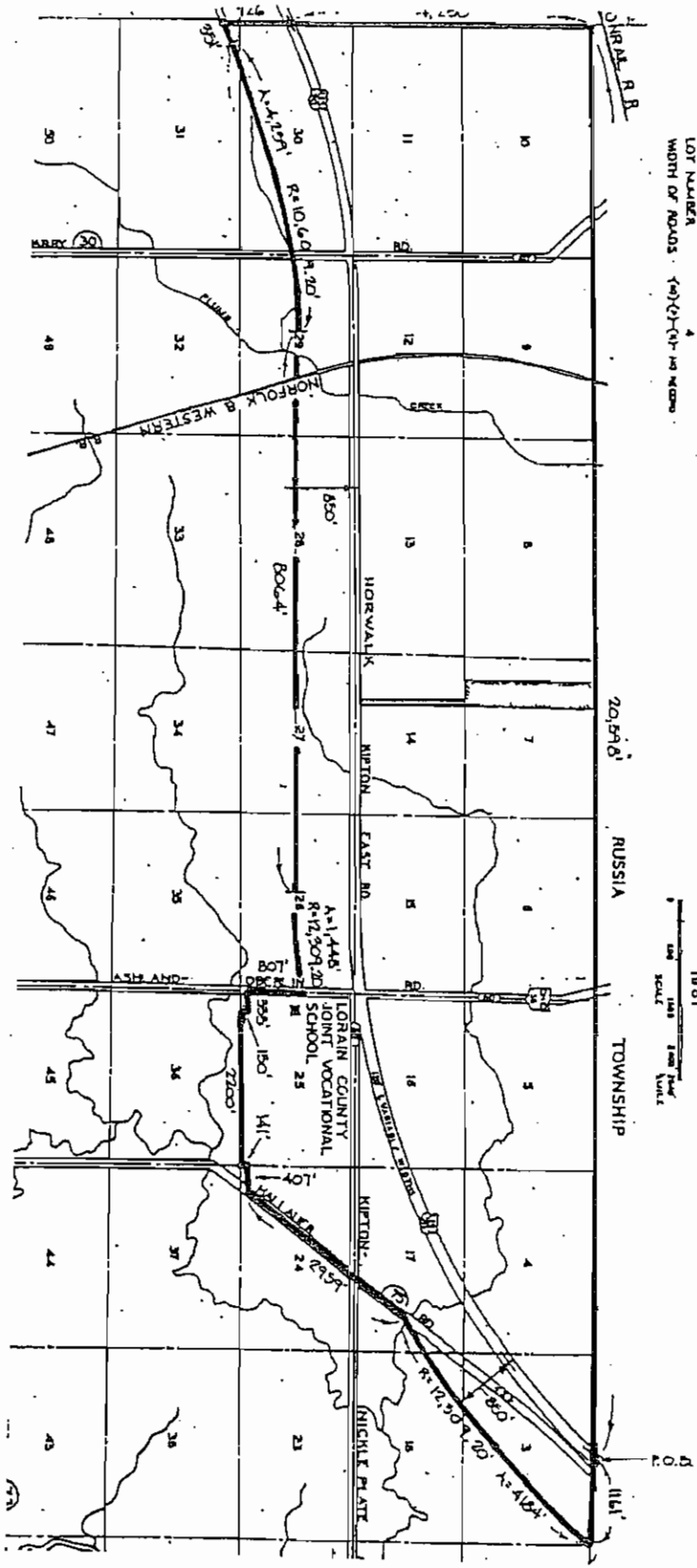
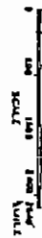

WHEREAS, said petition was filed as an Expedited Type 1 Annexation as authorized under R.C. 709.022 and the Board of Commissioners met on December 15, 2005, the next regular session following filing of the petition;

WHEREAS, Assistant County Prosecutor Innes said this Expedited Type 1 annexation does not require a hearing. The petition has been signed by all owners, a map and legal description were received along with the agent and an annexation agreement; and

WHEREAS, Commissioner Blair asked if there were any comments to be paid for or against; and there being none; and

WHEREAS, the petition read as follows:

Doren C. Portman and Joann J. Portman (collectively, the "Portmans") are the sole owners of the real property located at 14911 State Route 58, Oberlin, Ohio, further known as parcels numbered 1400016000018 and 1400016000031 (the "Subject Property"). WXZ Acquisition Co., LLC ("WXZ") has entered into a Purchase of Sale Agreement with the Portmans to acquire the Subject Property for development, subject to this Petition for Annexation on an Expedited 1 basis. The Subject Property contains 1.77 acres of land.

The Portmans and WXZ hereby petition for honorable body to annex the Subject Property to the City of Oberlin, Lorain County, Ohio.

This Petition for Annexation is being made pursuant to that certain Agreement between the City of Oberlin and the Board of Township Trustees of Pittsfield Township, Lorain County, Ohio dated August 2, 1991 in which the Township has agreed not to object to the annexation of property to the City of Oberlin if such property is located within the geographical area defined therein. 
1. The Petition contains an accurate legal description of the perimeter of the territory proposed to be annexed.


