WHEREAS, Petition request was received from the City of Elyria, Law Director Terry Shilling on November 29, 2007 pursuant to ORC 503.07 for an order changing the boundaries of Ely Township to include the 16.122 acres owned by John Vanco, et al, annexed to the city of Elyria from Elyria Township; and

WHEREAS, Board of County Commissioners of Lorain County, Ohio adopted Resolution No. 07-190 on March 15, 2007 annexed 16.122 acres from Elyria Township to the City of Elyria pursuant to ORC 709.022 (Vanco – expedited 1); and

WHEREAS, said Petition along with Map was forwarded to the County Engineer and County Auditor for their review and findings; and

WHEREAS, the following documents were received;

- a. December 5, 2007 Engineer stated the request to confirm boundaries is consistent with the property annexed
- b. December 10, 2007 Certificate of filing of said petition

NOW, THEREFORE BE IT RESOVLED, by the Lorain County Board of Commissioners that after review and recommendation of the Lorain County Engineer we do and hereby grant the request of the City of Elyria, by Law Director, Terry Shilling and conform boundaries pursuant to Section 503.07 of the Ohio Revised Code; Resolution No. 2007-141 confirmed and Petition of the City of Elyria, Ohio reads as follows:

'The City of Elyria, Ohio by Terry S. Shilling, Law Director, petitions the Board of County Commissioners of Lorain County, Ohio, pursuant to RC 503.07, for an order changing the boundaries of Ely Township to include the 16.122 acres owned by John Vanco, et al, annexed to the City of Elyria from Elyria Township and for such other action as may be proper.

The boundary lines to be changed are those needed to conform to the City of Elvria's annexation as describe don't he attached "Exhibit A".

The change of boundary lines shall reflect the removal of the annexed territory from its present township and reflect the territory's inclusion within the corporate limits of the City of Elyria and within the boundaries of Ely Township.

This petition is filed under the authority of Ordinance No. 2007-141, passed November 19, 2007, a true copy of which is attached, as "Exhibit A".

WHEREAS, Situated in the Township of Elyria, County of Lorain, State of Ohio, and being part of Original Elyria Township Lots 5 and 6 West of the Black River; and being part of the 17.84 acre parcel of land as described in Lorain County Document No. 2006-0167315 to Andrew Pavlenda, John P. Vanco and Claire M. Vanco; and being more definitely described as follows:

BEGINNING in the centerline of Murray Ridge Road (width varies) at the intersection within in the line common to Original Lots 5 and 6;

Thence along the centerline of Murray Ridge Road South 27°16'48" East 876.62 feet to the northwest corner of the 0.40-acre parcel of land described in Lorain County Deed Volume 1081 Page 162, Parcel #2 to the City of Elyria;

Thence along the north line of the City of Elyria's 0.40-acre parcel South 89°52'29" East 33.79 feet to a pin set in the east line of Murray Ridge Road and the PRINCIPAL PLACE OF BEGINNING of the land herein described;

Thence continuing along the north line of the City of Elyria's 0.40-acre parcel South 89°52'29"East 298.03 feet to an iron pin found in the west line of the 2.17-acre parcel of land described in Lorain County O.R. Volume 672 Page 879 to the Lorain County Metropolitan Park District;

Thence along the west line of the Metropark's 2.17-acre parcel North 37°57'32" east 1060.0-2 feet to a pin set at the southeast corner o the 11.04-acre parcel described in Lorain County document No. 2005-0094632 to Kenneth M and Rosemarie A. Stout;

Thence along the south line of Stout's 11.04-acre parcel and then the south lien of the 1.12-acre parcel of land described in Lorain County document NO. 2003-0902178 to Adam T. and Kelley E. Hoyt North 89°56'20" West 1381.48 feet to a pin set in the east line of Murray Ridge Road;

Thence along the east line of Murray Ridge Road South 27°16'48" East 941.29 feet to the principal place of beginning;

Containing within said bounds 16.1227 acre of land, more or less, of which 1.6905 acres lie in Original Lot 5 and 14.4322 acres lie in Original Lot 6, but subject to all legal highways and easements of record as surveyed by Dale Haywood, Registered State of Ohio Surveyor No. 8284, in February 2007.

Bearings are to be assumed meridian and intended to describe angles only. The basis of bearings is South 27°16'48" East for the centerline of Murray Ridge Road.
