ORDINANCE NO. 10-93

AN ORDINANCE TO CHANGE THE NAME OF ROCKWOOD COURT IN AVON WOODS SUBDIVISION NO. 3 TO APPLEWOOD COURT AND DECLARING AN EMERGENCY

WHEREAS, the subdivider of Avon Woods Subdivision No. 3, and persons owning property on Rockwood Court in the Municipal Corporation have requested a formal change in the name of Rockwood Court, as shown on the plat for Avon Woods Subdivision No. 3 to Applewood Court, by which the street is commonly known, to correct an error made on the original subdivision plans.

NOW, THEREFORE, HE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1. That the street known as Rockwood Court as shown in the plat for Avon Woods Subdivision No. 3, recorded as plat volume 35, pages 13 through 15 at Lorain County Records is hereby changed to Applewood Court.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the need to change the name to that by which it is popularly known, as desired by the residents and subdivider of said street and to correct an error made in the original subdivision plans; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
