ORDINANCE NO. 104-87

ORDINANCE TO ACCEPT RIDGELAND DRIVE AS A DEDICATED STREET AND PUBLIC HIGHWAY IN THE CITY OF AVON, LORAIN COUNTY, OHIO AND DECLARING AN EMERGENCY

WHEREAS, the owners of the premises described herein dedicate to the City of Avon, Lorain County, Ohio, the following described premises to be used as a street and public highway as part of land plat accepted by Ordinance 176-64; and

WHEREAS, the City has been maintaining said street and public highway since acceptance and recording of the Plat for said property; and

WHEREAS, the owner of record of said street is the City of Avon; and

WHEREAS, the City Engineer has represented to the City that it is for the best interests of the City to accept the following described premises as a dedicated street and public highway:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1. That upon the recommendation of the City Engineer, the City of Avon, Lorain County, Ohio, does hereby accept the following described premises as a dedicated street and public highway to be known as Ridgeland Drive:

Situated in the City of Avon, County of Lorain and State of Ohio and being part of Original Avon Township Section 10 and being Ridgeland Drive (60 feet wide and a cul de sac) as shown on plat of Avon Acre Farms Subdivision No. 2 recorded in Volume 24, Page 3 of the Lorain County Map Records.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in a meeting of this Council, and that all deliberations by this Council and of any of its committees that consulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of Avon residents for which reason and other reasons manifest of this Council the Ordinance hereby declared to be an emergency Ordinance and shall take effect and be enforced immediately after the passage and approval by the Mayor.
