



Situated in the Township of Camden, County of Lorain, State of Ohio, and being known as part of Original Lot No. 19, Tract 9, bounded and described herein as follows:

Commencing at a railroad spike at the intersection of the centerline of Betts Road, 60 feet width and Gore Orphanage Road, 60 feet in width; said point also being the southwesterly corner of Original Lot No. 36;
