ORDINANCE NO._////

An Ordinance vacating that portion of Woodhaven Drive from the westerly right-of-way line of Lewis Avenue, westerly to the east right-of-way line of Avon-Beldon Road; and that portion of Woodstock Street from the Southerly right-of-way line of Groveland Drive southerly to the rear lot line of the sublots now abutting the southerly right-of-way of said Woodhaven Drive within said Municipality; and declaring an emergency.

WHEREAS, The Avon Lake (Ohio) Board of Education, owner of the sublots abutting and adjacent to the portions of Woodhaven Drive and Woodstock Street, proposed to be vacated, submitted its petition to the Council of Avon Lake, Ohio, on 9-8-56, praying that Woodhaven Drive from the westerly right-of-way line of Lewis Avenue, westerly to the east right-of-way line of Avon-Beldon Road; and that portion of Woodstock Street from the Southerly right-of-way line of Groveland Drive southerly to the rear lot line of the sublots now abutting the southerly right-of-way of said Woodhaven Drive, within the Municipality of Avon Lake, Ohio, between the points named, be vacated; and

WHEREAS, Notice of the pendency of said petition was authorized by Council, following the recommendation of the Municipal Planning Commission and the independent consideration of Council, by Resolution No. 446, passed Aug. 20, 1956; and

WHEREAS, Notice of the pendency and prayer of said petition has been given as required by law, by publication in The Lorain Journal, Lorain County, Ohio, a newspaper of general circulation in the corporation, for six consecutive weeks ending October 8, 1956; and

WHEREAS: Council, upon hearing, is satisfied that there is good cause for such vacation as prayed for, that it will not be detrimental to the general interest, and ought to be made.

BE IT ORDAINED BY THE COUNCIL OF THE CHARTER MUNICIPALITY OF AVON LAKE, STATE OF OHIO:

Section 1, That that portion of Woodhaven Drive from the westerly right-of-way line of Lewis Avenue, westerly to the east right-of-way line of Avon-Beldon Road; and that portion of Woodstock Street from the southerly right-of-way line of Groveland Drive southerly to the rear lot line of the sublots now abutting the southerly right-of-way of said Woodhaven Drive within the Municipality of Avon Lake, Ohio, be and the same are hereby vacated.

Section 2, That this Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity of proceeding forthwith with the school facility expansion program within the Municipality of Avon Lake, Ohio, and otherwise providing urgently needed educational facilities for the increased school enrollment, the same being necessary for the preservation of peace, health and safety within the Municipality. Therefore this Ordinance shall take effect and be in force from and after its passage.
