## ORDINANCE NO. 116-93

AN ORDINANCE TO CHANGE THE NAME OF A PORTION OF HOLLY LANE TO FALCON CREST IN SCHAFER IRWIN SUBDIVISION NO. 2 AND DECLARING AN EMERGENCY

WHEREAS, the owner of property on Holly Lane near the Eagle Creek Subdivision has requested a formal change in the name of the Easterly 95.81 feet of Holly Lane to Falcon Crest to conform to the street name in the Eagle Creek Subdivision. the Eagle Creek Subdivision. interest

WHEREAS, Council deems it in the best of the municiaplity to conform to the plan and street name in the Eagle Creek Subdivision to grant the name change.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

Section 1. That the subdivison plat for Schafer Irwin Subdivision No. 2 recorded at Volume 43, Page 16 of Lorain County Records shall be amended to change the name of the Easterly 95.81 feet of Holly Lane (from the first monument box West of the Eagle Creek Subdivision to the entrance to the Eagle Creek Subdivision) from Holly Lane to Falcon Crest.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in a meeting of this Council, and that all deliberations by this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Avon, the immediate emergency being the necessity and desirability to change the name of Dogwood Street to Deerfield Drive to conform to the plans approved by the Planning Commission and other reasons manifest to this Council, and that the Ordinance shall take effect and be in force immediately after passage and approval by the Mayor.
