

AN ORDINANCE ACCEPTING THE LANDINGS AT MARTIN'S RUN SUBDIVISION NO. 1 - PHASE 3 DEDICATION PLAT IN THE CITY OF LORAIN AND DECLARING AN EMERGENCY

WHEREAS, the Lorain City Planning Commission approved The Landings at Martin's Run Subdivision No. 1 - Phase 3 Dedication Plat in the City of Lorain, Ohio at their regular meeting held on May 4, 2005; and

WHEREAS, Lorain City Council considered the recommendation of the Lorain City Planning Commission's approval of The Landings at Martin's Run Subdivision No. 1 - Phase 3 Dedication Plat, at the regular Council Meeting held on May 16, 2005; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN:

SECTION I. That The Landings at Martin's Run Subdivision No. 1 - Phase 3 Dedication Plat, be and the same is hereby approved and accepted.

SECTION II. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Ohio Revised Code 121.22.

SECTION III. That this Ordinance is hereby declared to be an emergency, the nature of which is the immediate need to continue the economic development and growth of the community and to accept real property interests which are beneficial to Lorain and its citizens without undue delay and burden in order to preserve the health, welfare, and safety of the citizens of the City of Lorain. Therefore, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, providing it receives the statutory requirements for passage, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
