

AN ORDINANCE CHANGING THE NAME OF BROSKI DRIVE IN EDGEWOOD ESTATES SUBDIVISION, EXTENDING FROM EDGEWOOD DRIVE TO TANGLEWOOD COURT, TO ROSECREST DRIVE IN THE CITY OF LORAIN, OHIO.

BE IT ORDAINED by the Council of the City of Lorain, State of Ohio.

SECTION 1. That the name of Broski Drive extending from Edgewood Drive to Tanglewood Court in the Edgewood Estates Subdivisions be changed and that the name of Rosecrest Drive be assigned to said street, upon the passage of this Ordinance.

SECTION 2. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

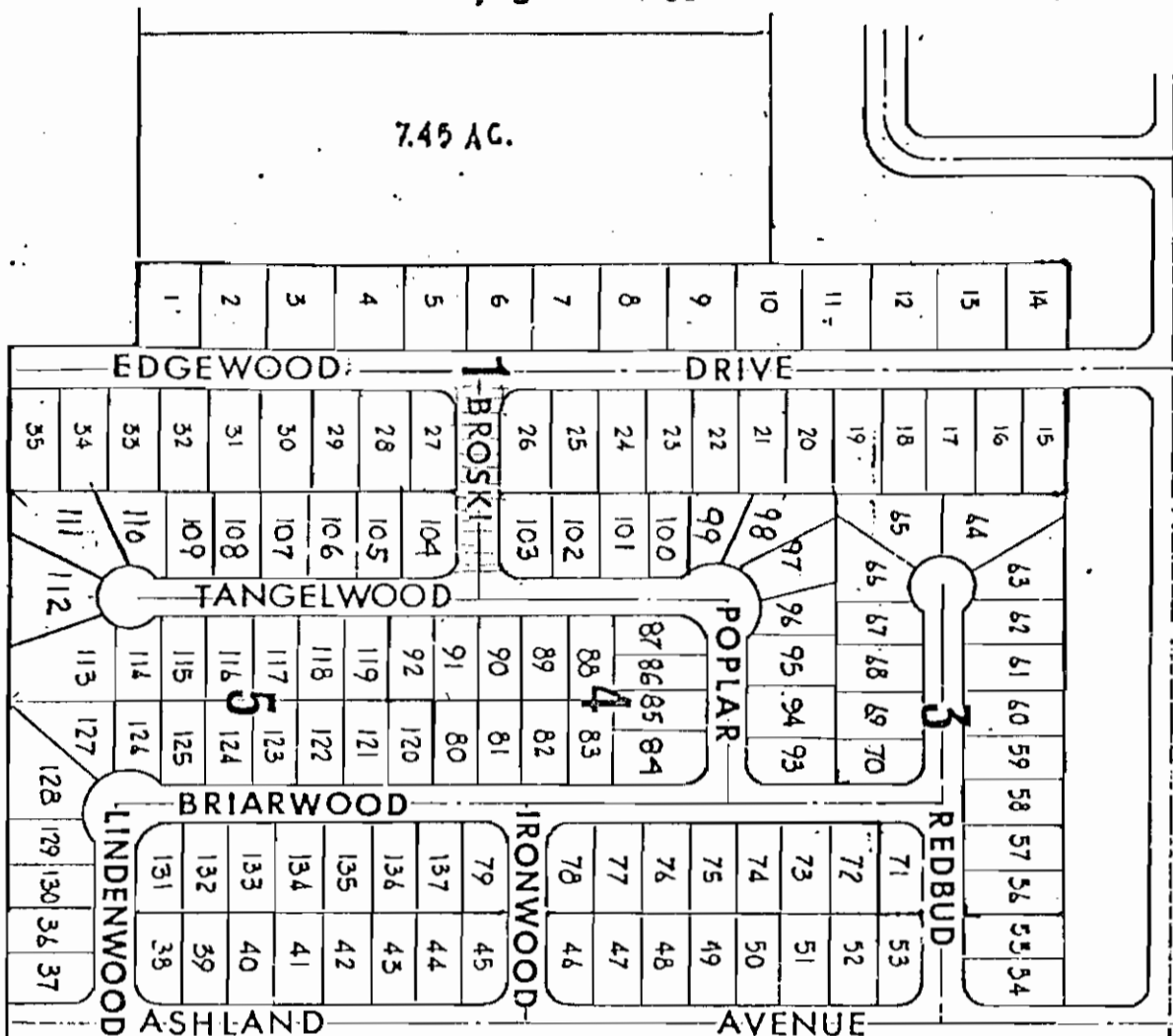
