ORDINANCE NO. 13-68

ORDINANCE ACCEPTING APPLICATION FOR ANNEXATION.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, COUNTY OF LORAIN, STATE OF OHIO:

Section 1. That the application of Curtis L. Nelson for the annexation of the following described territory in the County of Lorain and adjacent to the City of Lorain, Ohio, to wit:

Situated in the Township of Sheffield, County of Lorain, and State of Ohio. Being known as part of Original Lots Nos. 102 and 103, Sheffield Township, and more definitely described as follows:

Beginning in the line between Sheffield Township on the East, and Black River Township on the West, said place of beginning being at the intersection of the center line of West 37th Street, which line is also the Southern corporation line of the City of Lorain, with the West line of Sheffield Township.

Thence Southerly, in the West line of Sheffield Township, to the South sideline of Lincoln Street.

Thence Easterly, in the South sideline of Lincoln Street, extended to the East sideline of Broadway.

Thence Northerly, in the East sideline of Broadway, to the South sideline of Lincoln Street.

Thence Easterly, in the South sideline of Lincoln Street, extended to the East sideline of Elyria Avenue.

Thence Northerly, in the East sideline of Elyria Avenue, to the South sideline of Olive Street.

Thence Easterly, in the South sideline of Olive Street, to the West sideline of Clifton Avenue.

Thence Southerly, in the West sideline of Clifton Avenue, to the South sideline of Harriet Street.

Thence Easterly, in the South Sideline of Harriet Street, extended to the East sideline of Russell Avenue.

Thence Northerly, in the East sideline of Russell Avenue, to the South sideline of Olive Street.

Thence Easterly, in the South sideline of Olive Street, to the East sideline of Dallas Avenue.

Thence Northerly, in the East sideline of Dallas Avenue, to the South sideline of East 38th Street, extended Westerly.

Thence Easterly, in the South sideline of East 38th Street, to the East sideline of Dallas Avenue.

Thence Northerly, in the East sideline of Dallas Avenue, to the center line of East 36th Street, and the corporation limits of the City of Lorain.

Thence Westerly, in the South Corporate line of the City of Lorain, to the East sideline of Broadway. Thence Southerly, in the East sideline of Broadway, to the center line of East 37th Street.

Thence Westerly, in the center line of East 37th Street, to the place of beginning, be it the same, more or less, but subject to all legal highways.

An accurate map of which territory, together with the petition for its annexation and other papers relating thereto, and a certified transcript of the proceedings of the County Commissioners, in relation thereto, are on file with the Auditor of the City of Lorain, Ohio, and be and the same is hereby accepted, and to become a part of the FIFTH Ward of the City of Lorain, Ohio, and that the Sheffield Township Zoning laws be adopted for this area and the laws be subject to the administrative Boards and Commissions of the City of Lorain.

Section 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
