## AM ORDINANCE APPROVING PLANS FOR BAUMMART ROAD. (COUNTY KOAD NG. 51)

WHEREAS, the Director of Highways is considering improving a portion of the public highway which is described as follows:

Beginning at the intersection of County Road No. 51 and the south corporation line of the City of Lorain thence northerly along County Road No. 51 approximately 3525 feet and there terminate. The improvement consists of adding curb and gutter on the inside of an existing 24 foot pavement, that was constructed on a four-lane right of way, and constructing an additional 24 foot pavement with curb and gutter on the inside including all necessary grading, drainage and other pertinent construction items. The two 24 foot pavements will be separated by a 16 foot grassed median to match the pavements at each end of the proposed improvement, and;

WHEREAS, the plans for this improvement are now complete and have been approved by the Lorain County Engineer, and;

WHEREAS, the Lorain County Commissioners have passed Resolution No. 71-12 approving said plans and certifying that the necessary right of way is available, and;

WHEREAS, Lorain City Council did on 5 October 1970 pass Ordinance 152-70 consenting to the construction of the improvement in secondance with plans, specifications, and estimates as approved by the Highway Director, and;

WHEREAS, the State Highway Department requires the approval of said plans by the Lorain City Council,

NOW THEREFORE, Be it ordained by the Council of the City of Lorain, Ohio.

SECTION 1. That the plans for the improvement of Lorain County Baumbert Road CR 51 as prepared by Richland Engineering Limited, consulting engineers, and approved by the Lorain County Engineer on January 4, 1971, and by the Lorain County Board of Commissioners by Resolution 71-12, are hereby approved and it is hereby certified that the necessary right of way is available.

SECTION 2. That the project will be maintained in a manner satisfactory to the Director of High/ays, State of Chio, or his duly authorised representative and that ample provisions will be made each year for such maintenance and repair, done under authority of sections 723.01, 5535.01, 5555.02, 5557.02 and 5591.02 Et.Seq. of the revised code of Chio.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the said City, and for the further reason that the immediate construction of said improvement is necessary to protect the health of the abutting owners and the inhabitants of the City; wherefore, this Ordinance shall be in full force and effect from and immediately after its passege and approval by the Mayor.
