ORDINANCE NO. /301-77

AN ORDINANCE VACATING THAT PORTION OF SPRUCE STREET FROM JAYCOX ROAD WESTERLY A DISTANCE OF 120.59 FEET, AND OAK STREET FROM JAYCOX ROAD WEST-ERLY A DISTANCE OF 120.08 FEET.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, OHIO:

Section 1. That this Council does hereby declare that there is good reason, and that it will not be detrimental to the general interests of the inhabitants of the City, to vacate Spruce Street from Jaycox Road Westerly a distance of 120.59 feet and Oak Street from Jaycox Road Westerly a distance of 120.08 feet, and for these reasons said streets be and the same are hereby vacated between the termini mentioned above.

Section 2. That upon the effective date of this ordinance the Law Director be and he hereby is authorized and directed to transmit a copy of this ordinance to the County Auditor and Recorder, properly certified, and do those things necessary to cause the vacation of the streets to show upon the official maps and records of the City, subject to a 20' ensement, 10' on atthe sails of centraline for utilities on each streetion 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
