

ORDINANCE NO. 131

AN ORDINANCE TO CHANGE THE NAMES OF THE FOLLOWING STREETS: DRAKE STREET AT THE NORTH END OF WALLACE STREET TO LEWIS STREET; ELM STREET BETWEEN RIDGEVIEW BOULEVARD AND ALBERT AVENUE TO ELDER STREET; FOREST STREET BETWEEN ROSEBELLIE AVENUE AND ALBERT AVENUE TO WOOD STREET; MAIN STREET BETWEEN STATE ROUTE 76 AND LAKESIDE DRIVE TO SHAW DRIVE; MARK STREET BETWEEN BLANCHARD DRIVE AND DAVIS DRIVE TO CLARK STREET; THAT PART OF SYCAMORE STREET THAT CROSSES DYKE AVENUE NORTH OF STATE ROUTE 10 TO SINGH STREET, AND DECLARING AN EMERGENCY.

BE IT ORDAINED, by the Council of the City of North Ridgeville,

State of Ohio:

Section 1: - That the Council has determined after hearing upon same, that there is good cause shown for the change in the names of the streets as hereinbelow set forth in Section 2 and that said change in the names will not be detrimental to general interest.

Section 2: - That from and after the effective date of this ordinance, the names of the following streets are hereby changed so that

+ DRAKE STREET, at the North end of Wallace Street in the Cleveland Road Home Site Allotment shall be LEWIS STREET ✓

+ ELM STREET between Ridgeview Boulevard and Albert Avenue in the Center Ridge Heights Allotment shall be ELDER STREET ✓

* FOREST STREET between Rosebellie Avenue and Albert Avenue in the Center Ridge Heights Allotment shall be WOOD STREET ✓

+ MAIN STREET between State Route 76 and Lakeside Drive in the Home Crest Park Allotment shall be SHAW DRIVE ✓

+ MARK STREET between Blanchard Drive and Davis Drive, in West Port Allotment shall be CLARK STREET ✓

+ That part of Sycamore Street that crosses Dyke Avenue North of State Route 10 in Meadow's No. 1 Allotment shall be SINGH STREET ✓

Section 3: - That this ordinance is hereby declared to be an

emergency measure, necessary for the immediate preservation of the public peace, health and safety of the residents of the City of North Ridgeville by providing for the change of names of streets having duplicate names, therefore this ordinance shall take effect and be in force from and after passage and approval.
