ORDINANCE NO. **1321** -77

AN ORDINANCE DIRECTING THAT THE VACATED STREET UNDER THE PROVISIONS OF ORDINANCE 1301-77 BE TRANSFERRED EQUALLY TO ABUTTING PROPERTY OWNERS ON EACH SIDE OF THE STREET, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO:

Section 1. That the portion of Spruce Street, <sup>and OAK ST.</sup> vacated by Ordinance 1301-77 passed by this Council be transferred to the abutting property owners with the owner on each side of the street receiving one half of the vacated portion abutting his property.

Section 2. That the Engineer be and he hereby is authorized to furnish the Engineer, Treasurer, and Auditor of Lorain County data necessary to effect such transfer.

Section 3. That this ordinance is and is hereby declared to be an emergency measure the emergency being the immediate necessity to provide for the public health, welfare, and safety of the inhabitants of the City of North Ridgeville, Ohio by removing from the control and care of the City property which is no longer needed for a municipal purpose; wherefore this ordinance shall take effect and be in force from and after its passage and approval.
