ORDINANCE NO. 1329-77

AN ORDINANCE VACATING ROOSEVELT STREET  
BETWEEN THERESA STREET AND FRANCES STREET RES-  
ERVING THEREIN AN EASEMENT TO THE CITY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH  
RIDGEVILLE, LORAIN COUNTY, OHIO:

Section 1. That Roosevelt Street between Theresa Street  
and Frances Street be and the same is hereby vacated.

Section 2. That the vacated area be transferred to the abut-  
ing property owners in equal amounts upon payment by these owners of  
the property of the expenses incident to the transfer to include title  
search, recording fees, and all other fees and costs in connection  
therewith.

Section 3. That the City does retain an easement ~~thirty~~ <sup>TWENTY 20</sup> (30)  
feet in width, being ~~15~~ <sup>20</sup> feet on each side of the center of the  
right of way for utilities and other municipal purposes.

Section 4. That the Engineer be and he is hereby author-  
ized to prepare and submit necessary data required to effect the trans-  
fer to the Engineer, Auditor, and Recorder of Lorain County, Ohio.

Section 5. That this ordinance shall take effect and be in  
force from and after the earliest period allowed by law.
