ORDINANCE NO. 140-78

- Section 2. The Clerk of Council is hereby directed to foreward a certified copy of this Ordinance to the Postmaster, Lorain, Ohio.
- Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees which resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


