ORDINANCE NO. 1485 -79

AN ORDINANCE ACCEPTING BEHM DRIVE AND CRESTVIEW SUBDIVISION #3 AS A DEDICATED PUBLIC STREET AND DECLARING AN EMERGENCY.

WHEREAS, the council of the City of North Ridgeville, Ohio has determined that Behm Drive in the City of North Ridgeville, Ohio in Crestview Subdivision #3 has been properly installed and meets all city engineering and code requirements; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, OHIO:

SECTION 1: Behm Drive, as dedicated to public use as a street by Maplecrest Investment Corp., and as shown on the plat of Crestview Subdivision #3, accepted by Ordinance No. 1355-78, passed February 6, 1978, is hereby accepted as a street for public use;

SECTION 2: That this ordinance is hereby declared to be an emergency measure, the emergency being the immediate need to provide for the public health, safety and welfare of the citizens of North Ridgeville, Ohio by accepting for public use Behm Drive; wherefore this ordinance shall take effect and be in force immediately upon its passage and approval.
