

ORDINANCE NO. 16702

AN ORDINANCE CHANGING THE NAME OF
15TH STREET AND 16TH STREET
IN THE NEW CENTURY SUBDIVISION
IN THE CITY OF LORAIN, OHIO AND
DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION 1. That the name of 15th Street in the New Century Village Subdivision be changed and that the name of Stonepath Street be assigned and 16th Street in the New Century Village Subdivision be changed and that the name of Arrowhead Street be assigned to said street, upon passage of this Ordinance.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the passage of the Ordinance were adopted in an open meeting of this Council and of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency, the emergency being the immediate need to change street names within the City, so as to avoid confusion, all for the health, safety and welfare of the City. Therefore, this ordinance shall take effect immediately upon its passage and approval of the Mayor providing it meets the statutory requirement for passage, otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

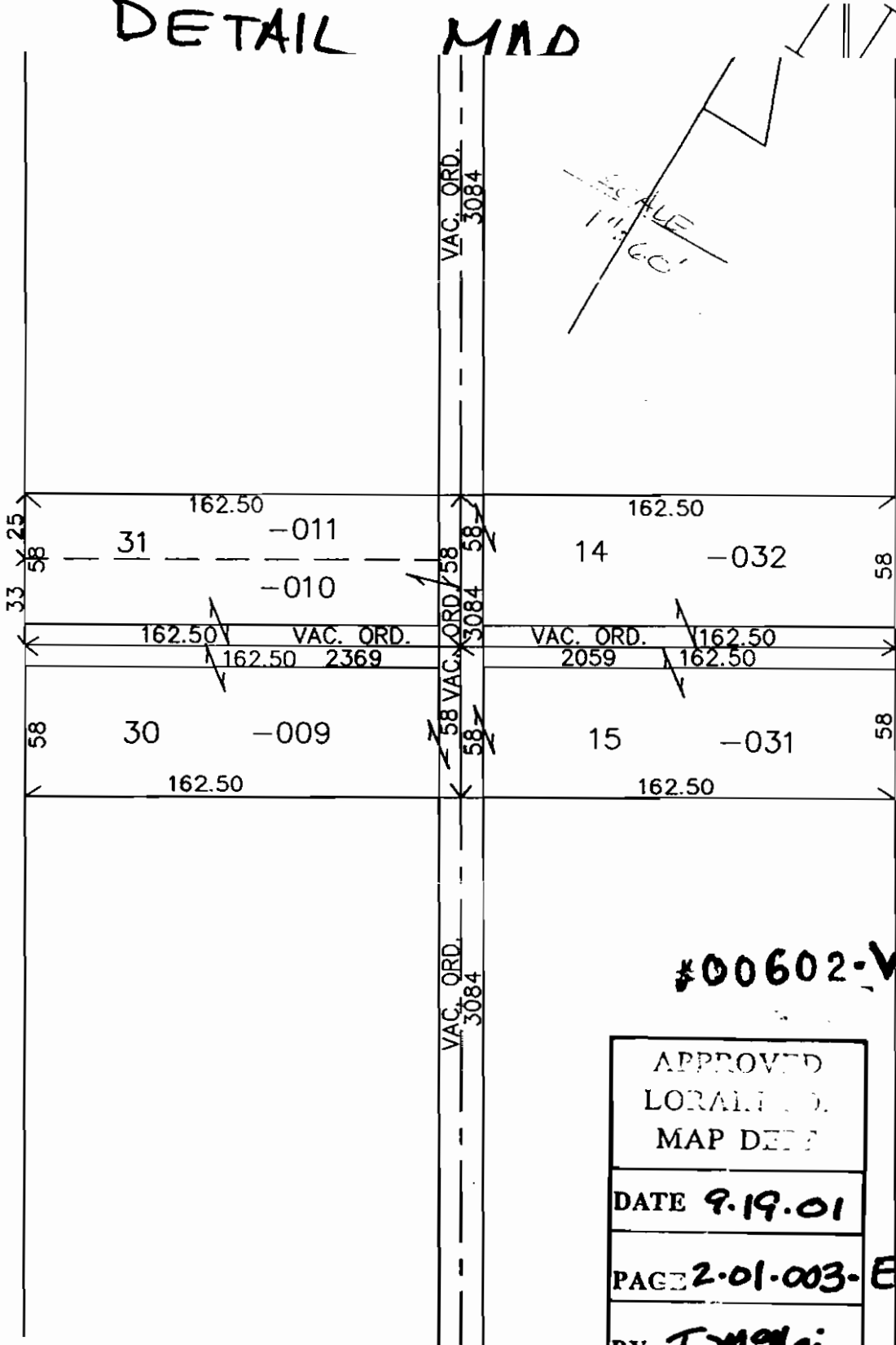
