ORDINANCE NO 168-86

AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF LORAIN, OHIO TO ENTER INTO AN AGREEMENT GRANTING AN EASEMENT AND RIGHT-OF-WAY TO THE CHURCH OF THE REDEEMER.

WHEREAS, Council for the City of Lorain, Ohio has received a request from The Church of The Redeemer to obtain an easement from the City of Lorain, Ohio as set forth in Exhibit "A", attached hereto and incorporated herein;

WHEREAS, Council has determined that there is good cause for granting such easement and that such granted interests in the property are not needed for municipal purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION I.

That the Mayor of the City of Lorain, Ohio, be and is hereby authorized to enter into an agreement granting to The Church of The Redeemer an easement and right-of-way together with the rights and privileges set forth in the Easement Agreement attached hereto and incorporated herein, marked as Exhibit "A" for purposes of constructing and maintaining building improvements thereon.

SECTION II.

That it is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.11, Ohio Revised Code.

SECTION III.

That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

BASEMENT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, The City of Lorain, Ohio, a municipal corporation without Charter, for and in consideration of the sum of one dollar, (\$1.00), and other valuable consideration, received to its full satisfaction of The Church of The Redeemer, the Grantee, does hereby grant unto Grantee, its successors and assigns, an Easement and Right-of-Way on the premises described in Exhibit "B", attached hereto and incorporated herein, together with the rights and privileges hereinafter set forth.

The Easement described above does not give the Grantee the authority to construct or erect any type of structure thereon. The Easement being granted is for the specific purposes of ingress and egress.

Grantor reserves the right to use the Right-of Way area in ways not inconsistent with the use of the area by the Grantee. Grantor reserves the right to inspect, operate, repair, replace, patrol, maintain and remove, under and along said Right-of-Way, such underground lines, pipe conduits and other usual fixtures and appurtenances as may be necessary, or become necessary in connection with underground utilities maintained by Grantor under the Right-of-Way.

The Easement and rights herein granted are subject to equal rights of other utilities in that portion of the premises set forth above for utility purposes.

TO HAVE AND TO HOLD said Easement rights and Right-of-Way to Grantee, its successors and assigns forever.

AND Grantor does for itself and its successors and assigns covenant that it is well and truly seized of the above described premises and has good right to grant the foregoing rights and privileges.
