2. The 15 foot wide alley situated between the Easterly line of Gladys Avenue and the Westerly line of Ethel Avenue, and being bounded on the North by the South-^oerly line of Sublots Nos. 616 to 632 inclusive, in said subdivision, as appears on said plat.
3. The 15 foot wide alley situated between the Easterly line of Ethel Avenue and the Westerly line of Grace Avenue, and being bounded on the North by the South-^oerly line of Sublots Nos. 598 to 615 inclusive of said subdivision as appears on said plat.
