ORDINANCE NO. 1810 -83

AN ORDINANCE REPEALING ORDINANCE NO. 1760-82, 1761-82 AND 1762-82, AND DECLARING AN EMERGENCY.

WHEREAS, the City of North Ridgeville, Ohio, has adopted a new policy for vacating streets within the City, and

WHEREAS, Ordinance Nos. 1760-82, 1761-82 and 1762-82 have not been fully carried into effect.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, OHIO:

SECTION 1: That Ordinance No. 1760-82, 1761-82 and 1762-82 are hereby repealed.

SECTION 2: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this council and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the public peace, health and welfare of the citizens of the City of North Ridgeville, Ohio, by providing for the repeal of Ordinance Nos. 1760-82, 1761-82 and 1762-82 providing for the vacating of certain streets within the City.

WHEREFORE, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
