## ORDINANCE NO. 1891-84

## AN ORDINANCE VACATING A PORTION OF KRUEGER DRIVE.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, OHIO:

That a part of Krueger Drive, described herein below be and the SECTION 1. same is hereby vacated.

SECTION 2. That part of Krueger Drive to be vacated is more fully described as follows:

> Situated in the City of North Ridgeville, County of Lorain and State of Ohio, being known as part of Krueger Drive as shown by the plat of Pike Lake Allotment of part of Original Ridgeville Township Lot No. 22, as recorded in Volume 21, Page 45 of Lorain County Plat Records, and more definitely described as follows:

> Beginning on the westerly sideline of Krueger Drive, 50 feet wide, at the Northeasterly corner of Sublot No. 17 in Pike Lake Allotment;

> Thence North 10 0' West in the Westerly sideline of Krueger Drive, a distance of 90.13 feet to a point of curvature:

> Thence in the arc of a curve in the sideline of Krueger Drive which deflects to the right, a distance of 218.63 feet to a point of reverse curve; said curve has a radius of 50.00 feet, a central angle of  $250^{\circ}$  31' 44" and a chord of 81.65 feet which bears South 550 44' 08" East;

> Thence in the arc of a curve in the Easterly sideline of Krueger Drive which deflects to the left, a distance of 30.77 feet to the point of tangency of said curve; said curve has a radius of 25.00 feet, a central angle of 700 31' 44" and a chord of 28.87 feet which bears South 34° 15' 52" West;

> Thence South 10 0' East in the Easterly sideline of Krueger Drive, a distance of 20.29 feet to a point;

> Thence due West, a distance of 50.01 feet to the Northeasterly corner of Submarine No. 17 and the place of beginning;

> Enclosing a parcel containing 0.241 acre, to be the same more or less, but subject to all legal highways.

That the portion of the street hereby vacated shall revert in SECTION 3. equal amounts to the abutting property owners subject to access rights for all properties abutting the street herein vacated.

SECTION 4. That the Engineer be and he is hereby authorized to prepare and submit necessary data required to effect the transfer to the ENgineer, Auditor and Recorder of Lorain County, Ohio. #15630


