VACATING THE NORTH-SOUTH ALLEY LYING BETWEEN WEST STREET AND MIDDLE STREET FROM JOHNS STREET SOUTH TO THE INTERSECTING EAST-WEST ALLEY AND RESERVING AN EASEMENT THEREIN

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WELLINGTON, OHIO:

That there is good cause for the vacation of a 33' alley lying between West Street and Middle Street and which extends South from the South side of Johns Street a distance of about 495 feet to its point of intersection with the North line of the East-West alley between West Street and Middle Streets.

II: That the 33' alley running South from Johns Street between West Street and Middle Street be and the same hereby is vacated, provided, however, that the Village of Wellington, for itself, its successors and assigns, shall reserve unto itself, its successors and assigns, the perpetual right, easement and privilege, to enter upon the same for the installation, repair, removal, construction and maintenance of public utility lines on, under, and over a strip of land ten (10) feet in width, which easement shall lie five (5) feet on either side of the centerline of said alley.

The Clerk is hereby directed to certify a copy of this ordinance to the County Auditor and County Recorder to carry out the provisions of this ordinance on the records of Lorain County.

That this ordinance shall take effect and be in force from and after its passage.
