

ORDINANCE NO. 2057

AN ORDINANCE VACATING PARTS OF COMMUNITY ROAD
AND ALLEN AVENUE IN THE VILLAGE OF SHEFFIELD
LAKE, OHIO.

WHEREAS, Jacob Levin, the owner of all the adjacent
land has presented a petition that the following parts of streets
in the Village of Sheffield Lake be vacated:

- (1) Community Road from the south boundary of Forest
Lawn Ave. to the north boundary of Holl Ave., being
all of said Community Road lying within the Knicker-
bocker Subdivision No. 2 of the Village of Sheffield
Lake.
- (2) Allen Ave. from the south boundary of Forest
Lawn Ave. to the north boundary of Holl Ave., being
all of said Allen Ave. lying within the Knicker-
bocker Subdivision No. 2 of the Village of Sheffield
Lake.

WHEREAS, no notice of the pendency and prayer of said
petition is required for the reason that said petitioner is the
owner of all the adjacent property and has consented in writing
thereto; and

WHEREAS, Council, upon hearing, is satisfied that there
is good cause for said vacation and it will not be detrimental to
the public interest;

NOW, THEREFORE, BE IT ORDAINED BY the council of the
Village of Sheffield Lake, State of Ohio:

SECTION 1. That Community Road from the south boundary
of Forest Lawn Avenue to the north boundary of Holl Avenue, being
all of said Community road lying within the Knickerbocker Subdivision,
Number 2 of the Village of Sheffield Lake, be and the same is
heraby vacated.

SECTION 2. Allen Ave. from the south boundary of Forest
Lawn Ave. to the north boundary of Holl Ave., being all of said
Allen Ave. lying within the Knickerbocker Subdivision No. 2 of
the Village of Sheffield Lake be and the same is hereby vacated.

SECTION 3. That this Ordinance is hereby declared to
be an emergency measure, the emergency being ^{the} immediate necessity
of vacating the above portions of said streets in order to obtain

substantial improvements to a portion of the Village which im-
provements are necessary for the general peace, health, and well-
fare of the residents of the Village of Sheffield Lake.

SECTION 7. That this ordinance shall take effect and
be in force from and after the earliest period allowed by law.
