I HEREBY CERTIFY

AN ORDINANCE VACATING A PORTION OF WESTIN WAY LOCATED WITHIN THE CITY OF ELYRIA, AND DECLARING AN EMERGENCY.

WHEREAS, this Council is satisfied that good cause has been shown for the vacation of a portion of Westin Way, which is located in the City of Elyria and that the vacation will not be detrimental to the general interest of the City of Elyria and needs to be made.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ELYRIA, STATE OF OHIO:

SECTION 1: That a portion of Westin Way, located in the City of Elyria, Lorain County, Ohio, and described in Exhibit "A" attached hereto and made a part hereof is hereby vacated.

SECTION 2: That the portion of Westin Way hereby vacated described in Exhibit "A" (Vacated Real Property) shall revert to Chestnut Plaza Ltd., an Ohio Limited Liability Company and the City of Elyria, Ohio, the abutting property owners, subject to the reservation of an Easement to the City of Elyria (Elyria) over the said Vacated Real Property: (1) for ingress and egress to real property owned by Elyria for a water tower which real property is described in Exhibit "B" attached hereto and made a part hereof; (2) for ingress and egress to real property owned by Chestnut Plaza Ltd., and known as Chestnut Commons Development, detailed in Exhibit "C" attached hereto and made a part hereof, and to that portion of Westin Way not vacated hereby; (3) for any utilities including, but not limited to sanitary and storm sewers, water mains, electrical, telephone and gas lines presently located or installed or to be located or installed or maintained on and in said Vacated Real Property by Elyria or any other utility provider and the continuing right of Elyria and any other utility provider to maintain said utilities and to enter upon said Vacated Real Property whenever reasonably necessary for the purposes of installing, inspecting, altering,

replacing, repairing, operating, relocating, removing and maintaining said utilities and appurtenances thereto. In the event Elyria exercises its rights under this Section 2, Elyria will be responsible only for the cost to restore the easement area to its prior grade. Property owner(s) shall be responsible for the cost of restoring any damaged or removed driveway or walkway or roadway surfaces or structures or any other improvements installed or located within said Vacated Real Property and easement area.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in meetings open to the public, in compliance with Ohio law.

SECTION 4: That Ordinance be and hereby is declared to be an emergency, the emergency being the need to approve the vacation so that the City of Elyria can go forth with the construction of Chestnut Commons Drive within the Northern Ohio 2004 construction season, and for the immediate preservation of the public peace, health, safety or welfare of the people of the City of Elyria; wherefore, this Ordinance shall be in full force and effect from and immediately after its passage and approval.

Thence South 89° 28' 52" West along the southerly right of way of Westin Way, 735.42 feet to a point;




