AN ORDINANCE PURSUANT TO OHIO REVISED CODE SECTION 709.04 ACCEPTING PETITION FOR ANNEXATION FROM ELYRIA TOWNSHIP TO THE CITY OF ELYRIA OF 16.122 ACRES OWNED BY JOHN VANCO, ET AL.
