ORDINANCE NO. 206-79

AN ORDINANCE VACATING THE ALLEY NORTH OF DEWITT STREET (15'WIDE) FROM THE EASTLINE OF CLIFTON AVENUE, EASTERLY 585.81 FEET TO THE WEST LINE OF RUSSELL STREET IN THE CITY OF LORAIN, OHIO.

WHEREAS, on the 29th day of October 1979, a petition signed by the owners of property abutting on the Alley north of Dewitt Street (15'wide) from the eastline of Clifton Avenue, easterly 585.81 feet to the west line of Russell Street in the City of Lorain, Ohio, was duly presented to Council, praying that said Alley be vacated, and

WHEREAS, under the provisions of Section 723.06, notice of the pendency and prayer of said petition is not required, and

WHEREAS, City Council is satisfied that there is good cause for such vacation as prayed for; that it will not be detrimental to the general interest and ought to be made.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

- SECTION 1. That the Alley north of Dewitt Street (15'wide) from the eastline of Clifton Avenue easterly 585.81 feet to the west line of Russell Street in the City of Lorain, Ohio, be the same hereby is vacated, subject, however, to the reservation that the City of Lorain, Ohio, reserves to itself and others, easements rights to construct or maintain sewer lines, water lines, gas lines, electric conduits, telephone and electric pole lines and other similar facilities under, on or above said Alley whenever deemed necessary by the City of Lorain, Ohio.
- SECTION 2. That one-half (1/2) of the width of said street shall revert to the abutting owners on each side of said Alley.
- SECTION 3. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public and in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.
- SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
