WHEREAS, Resolution No. 21-97, adopted February 10, 2021 received and journalized said petition to vacate existing Right Of Ways of Park Place Drive and Boardwalk Avenue, located in Original Lot 57, within Garden of Eaton Allotment No. 1, Eaton Township, Ohio that was received on February 4, 2021; and

WHEREAS, March 5, 2021 Ted Spillman, Lorain County Tax Map by email stated that the description is incorrect based off the Subdivision Survey by Mr. Gary Penfound. This is in concurrence with Robert Klaiber, Assistant County Engineer by email dated March 8, 2021; and

WHEREAS, March 8, 2021, Commissioners Clerk forwarded said email to Bryan Carlton on incorrect description; and

WHEREAS, March 15, 2021 Bryans S. and Barbara R. Carlton submitted an amended legal description as follows:

The description below represents a revision of the description previously submitted to vacate the roads within the described boundary, said roads are located in Original Lot 57 of Eaton Township, and said roads are 60' in width and are within Garden of Eaton Allotment No. 1, as recorded in Plat Volume 34, Page 75 of the Lorain County Map Records. The portion of road to be vacated in shown on Exhibit A and described within the bounds as follows:

Beginning at a point on the centerline of Capel Road (60' R/W) and a southeast corner of Garden of Eaton Allotment No. 1, said point being the principal place of beginning;

- Thence North 88°39'30" West a distance of 60.02 feet along the centerline of Capel Road and a south line of said Allotment to a point on the centerline of Capel Road and a southwest corner of said Allotment;
- Thence North 0°12'00" East a distance of 300.00 feet along a west line of said Allotment to a point on a southwest corner of said Allotment;
- Thence North 88°39'30" West a distance of 551.52 feet along a south line of said Allotment to a point on a west line of said Allotment;
- Thence North 2°40'00" West a distance of 1052.70 feet along a west line of said Allotment to a point on the northwest corner of said Allotment;
- Thence South 88°53'25" East a distance of 985.13 feet along a north line of said Allotment to a point on the northeast corner of said Allotment;
- Thence South 0°12'00" West a distance of 1054.32 feet along an east line of said Allotment to a point on a southeast corner of said Allotment;
- 7 Thence North 88°39'30" West a distance of 321.00 feet along a south line of said Allotment to a point on a southeast corner of said Allotment;
- Thence South 0°12'00" West a distance of 300.00 feet along an east line of said Allotment to the principal place of beginning;
