

ORDINANCE NO. 248-13

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY/SERVICE TO CLOSE EAST 17TH STREET BETWEEN BROADWAY AND ELYRIA AVENUE AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined that traffic travelling along East 17th Street between Broadway and Elyria Avenue creates a hazardous condition; and

WHEREAS, closing this section of road will improve the health, safety, and welfare of the citizens of Lorain.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LORAIN, OHIO:


SECTION 1: The Director of Public Safety/Service is hereby authorized to close East 17th Street between Broadway and Elyria Avenue.

SECTION 2: The Director of Public Safety/Service is authorized to direct city forces to construct and pay for materials relating to the closure of this section of street.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 4: That this ordinance is declared to be an emergency being the necessity to meet the construction season and to eliminate existing hazards to vehicular traffic of the citizens of Lorain, therefore it shall take effect and be in force immediately upon passage by Council and approval by the Mayor, providing it receives the affirmative vote of two-thirds of all members elected to City Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.




