ORDINANCE NO. 30-12

AN ORDINANCE APPROVING THE REVISION OF THE FINAL DEVELOPMENT PLAN FOR "THE MANORS AT MORNINGSIDE" LORAIN, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, the City of Lorain Planning Commission at their meeting of March 7, 2012, reviewed and recommended that the Revision of the Final Development Plan for "The Manors At Morningside" be approved; and

WHEREAS, said recommendation for approval was transmitted to Lorain City Council on March 19, 2012 in accordance with Section 1157 of the Lorain Codified Ordinances; and

WHEREAS, pursuant to Lorain Codified Ordinance Section 1157 within sixty (60) days after receipt of the recommendations of the Planning Commission Lorain City Council shall, by ordinance, either approve or disapprove the Revision of the Final Development Plan as presented.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION I That Lorain City Council hereby approves the Revision of the Final Development Plan as recommended by the Lorain Planning Commission of "The Manors At Morningside" located in Martins Run, Lorain, Ohio, a copy of said plan being attached hereto and marked "Exhibit A" and fully incorporated herein.

SECTION II That Lorain City Council hereby directs the Building Inspector to issue building permits only in accordance with this approved Revision to the Final Development Plan.

SECTION III That it is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION IV That this ordinance is hereby declared to be an emergency, the nature of the emergency being the immediate passage of this legislation as there are pending sales of lots for development within the City of Lorain dependent upon the immediate passage of this legislation. Therefore, this ordinance shall take effect immediately upon its passage and approval of the Mayor, providing it meets the statutory requirements for passage otherwise it shall take effect and be in force from and after the earliest period allowed by law.


