ORDINANCE NO. 35-05

AN ORDINANCE ACCEPTING THE PLAT OF THE DEERFIELD ESTATES SUBDIVISION NUMBER 1 IN THE CITY OF LORAIN AND DECLARING AN EMERGENCY

WHEREAS, the Lorain City Planning Commission approved the Deerfield Estates Subdivision No. 1, in the City of Lorain, Ohio at their regular meeting held on April 7, 2004; and

WHEREAS, Lorain City Council concurred with the recommendation of the Lorain City Planning Commission's approval of the Deerfield Estates Subdivision No. 1. Council Meeting held on April 19, 2004; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN:

That the Plat of the Deerfield Estates Subdivision No. 1, be and the same is hereby approved and accepted.

That it is found and determined that all formal actions of this Council concerning and SECTION II. relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Ohio Revised Code 121.22.

That this Ordinance is hereby declared to be an emergency, the nature of which is SECTION III. the immediate need to continue the economic development and growth of the community and to accept real property interests which are beneficial to Lorain and its citizens without undue delay and burden in order to preserve the health, welfare, and safety of the citizens of the City of Lorain. Therefore, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, providing it receives the statutory requirements for passage, otherwise it shall take effect and be in force from and after the earliest period allowed by law.


