

ORDINANCE NO. 40-91

AN ORDINANCE ACCEPTING THE PLAT OF OAKPOINT VILLAGE
SUBDIVISION NUMBER 3 TO THE CITY OF LORAIN, OHIO.

WHEREAS, the Lorain City Planning Commission approved the plat of Oak Point Village Subdivision Number Three at their regular meeting held on November 2, 1988; and

WHEREAS, Lorain City Council concurred with the Lorain City Planning Commission approval of Oak Point Village Subdivision Number Three at a council meeting held November 7, 1988.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION 1: That the plat of Oak Point Village Subdivision Number Three (Lots 43 through 66) in the City of Lorain be and the same is hereby approved.

SECTION 2: That it is found and determined that all found actions of this council concerning and relating to the passage of this ordinance were adopted in an open meeting of this council and of any of its Committees that resulted in such formal action, were in meetings open to the public and in compliance with all legal requirements including Section 121.22, Ohio Revised Code.

SECTION 3: That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
