

ORDINANCE NO 4158

Ordinance to vacate alley between East 31st Street and East 32nd St and between the alley west of Elyria Avenue and the alley east of and parallel with Broadway; Alley between Beech Avenue and the east line of Lot 54 and Lot 68 Stangs First Addition and between 22nd Street and 23rd Street; Alley between Washington Avenue and Long Avenue and between 18th Street and 19th, Street paralleling 18th and 19th streets; Alley between East 25th street and East 26th, street extending easterly from Elyria Avenue thence northerly to East 25th, street; Alley between West 23rd St and West 24th Street and westward from Oakdale Avenue to west line of W.A. Bramans 2nd Addition.

Whereas, petitions by persons owning lots in the immediate vicinity of alley between East 31st Street and East 32nd Street and between the alley west of Elyria Avenue and the alley east of and parallel with Broadway; Alley between Beech Avenue and the east line of Lot 54 and Lot 68 Stangs First Addition and between 22nd Street and 23rd Street; Alley between Washington Avenue and Long Avenue and between 18th Street and 19th Street, paralleling 18th and 19th Streets; Alley between East 25th street and East 26th street, extending easterly from Elyria Avenue thence northerly to East 25th, street; Alley between West 23rd St and West 24th Street and Westward from Oakdale Avenue to west line of W.A. Bramans 2nd Addition, were duly presented to Council praying that said streets, between the points named, be vacated and notice of the pendency and prayer of said petitions have been given as required by law, by publication in the Lorain Journal, a newspaper of general circulation in the corporation, for six consecutive weeks ending,

Whereas Council upon hearing, is satisfied that there is good cause for such vacation as prayed fro and that it will not be detrimental to the general interest and ought to be made, now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

Section 1. That Alley between East 31st street and East 32nd street and between the alley west of Elyria Avenue and the Alley east of and parallel with Broadway; Alley between Beech Avenue and the east line of Lot 54 and Lot 68 Stangs First Addition, and between East 22nd Street and 23rd Street; Alley between Washington Avenue and Long Avenue and between 18th Street and 19th Street, paralleling 18th and 19th Streets; Alley between East 25th Street and East 26th Street, extending easterly from Elyria Avenue thence northerly to East 25th Street; Alley between West 23rd St and West 24th Street and Westward from Oakdale Avenue to west line of W.A. Bramans 2nd Addition, be and the same are hereby vacated.

Section 2. That the City of Lorain, State of Ohio, expressly reserves to itself and assigns an easement in, to, through and over the above described premises for the purpose of construction, maintaining and repairing all necessary or desired electric light and power lines, telephone electrical signal lines, water and sewer lines;

Section 3. That this Ordinance be and remain in force from and after the earliest period allowed by law.
