

Ordinance No. 430

An ordinance is amended Sections two (2) and three (3) of ordinance number two-hundred and seventy (270) and to reestablish dock or wharf lines.

Sec. 1. Be it ordained by the Council of the City of Lorain that Sections two (2) and three (3) of ordinance number two-hundred and seventy (270), passed July 26th 1894 and entitled "to establish the dock and wharf lines of the Black River between the Erie Avenue Bridge and points opposite the foot of the Island in Sheffield Township; also to establish the triangulation to which the same has reference", be and the same are hereby amended so as to read as follows;

The said dock or wharf lines on the southwesterly side of said Black river commence at the point of intersection of the easterly line of Erie avenue and a line 97° 08' from the stone monument E. W.; thence continuing on said line from E. W. to its intersection with a line 207° 29' from stone monument G; thence to the point of intersection of the lines 169° 22' from C and 109° 31' from E.
